**JOSEPH GRANT’S REPLY TO HARDIN WIND LLC’S MEMORANDUM CONTRA
TO THE PETITION TO INTERVENE**

In response to Hardin Wind, LLC’s Memorandum Contra to my Petition for Leave to Intervene, Hardin Wind, LLC contends that I live outside of the project area. Hardin Wind LLC’s classification of my property as outside the “project area” is misleading. The project boundary is US Highway 68, which is the road I live on. My mail box is on the west side of the road and is in the “project area,” but my house is on the east side, and according to Hardin Wind, LLC, is not in the project area. Hardin Wind LLC created the map of the project area, and they should not be permitted to prejudice me by using their map as a sword to prevent my intervention in the case. Furthermore, shadow flicker will be seen on the east side of US Highway 68. See Application, Exhibit Q, Shadow Flicker Maps, in Case No. 13-1177-EL-BGN filed by Hardin Wind LLC July 1, 2013. Additionally, noise levels from the turbine will be elevated to between 40-45 db. *Id.* at Exhibit P. If a resident’s home is close enough to feel the negative impacts of the project area than that resident’s home should be considered within the project area. In conclusion, I respectfully request intervention in the above captioned proceeding.
