PETITION OF AT&T OHIO FOR REVIEW OF A DECISION OF NEUSTAR - POOLING ADMINISTRATOR

AT&T Ohio, by its attorney and pursuant to 47 CFR § 52.15(g)(3)(iv), respectfully requests that the Public Utilities Commission of Ohio ("Commission") review and overturn the Pooling Administrator's ("PA" or "NeuStar") denial of AT&T Ohio's request for numbering resources, as more fully described herein.

An Ohio customer, University Hospitals, has requested a block of 2,000 consecutive numbers in the Terrace rate center. University Hospitals is expanding to multiple locations in the geographic area covered by the 216 area code. More specifically, University Hospitals has purchased another building located at 20800 Harvard Road, Beachwood, Ohio, adding to numerous other sites it already operates in the that same geographic area, and will likely expand further in that same area. In order to provide telecommunications services at the 20800 Harvard Road and surrounding locations, and to streamline its dialing plan in preparation for conversion to centralized trunking, University Hospitals requires a block of 2,000 consecutive Direct Inward Dialing ("DID") numbers and anticipates that the new numbers will be put into operation within the next two years. Moreover, so that the new numbers are compatible with the existing dialing plan, University Hospitals is requesting that the prefix of the

newly assigned numbers end with the digit 8 (i.e., (216) NX<u>8</u>-XXXX). (The existing telecommunications system will not accept a block of DID's with a prefix starting with a 0, 1, or 9).

The numbering resources in AT&T Ohio's numbering inventory are inadequate to meet University Hospitals' needs. Neither are two consecutive, uncontaminated blocks available for assignment from the Number Pooling Inventory. As such, AT&T Ohio requested NeuStar to assign a new NXX code and allocate two blocks for use by University Hospitals in the Terrace rate center. That request was denied because AT&T Ohio does not meet the two required FCC criteria to obtain numbering resources in the Terrace rate center. The FCC requires a months-to-exhaust ("MTE") of 6 months or fewer. AT&T Ohio is at a 138.93 MTE due to the low growth forecast and inventory that does not qualify for donation. In addition, the FCC requires utilization of 75% or higher and AT&T Ohio is at 66.89%. Thus, neither FCC criteria is met in this case.

The FCC's rules identify a procedure whereby denial of a numbering resource request can be brought to the appropriate state commission for review. 47 CFR § 52.15(g)(3)(iv) provides as follows:

(iv) The NANPA shall withhold numbering resources from any U.S. carrier that fails to comply with the reporting and numbering resource application requirements established in this part. The NANPA shall not issue numbering resources to a carrier without an Operating Company Number ("OCN"). The NANPA must notify the carrier in writing of its decision to withhold numbering resources within ten (10) days of receiving a request for numbering resources. The carrier may challenge the NANPA's decision to the appropriate state regulatory commission. The state regulatory commission may affirm or overturn the NANPA's decision to withhold numbering resources from the carrier based on its determination of compliance with the reporting and numbering resource application requirements herein.

In addition, the FCC's December 12, 2001 Order in its Number Resource Optimization Report and Order, CC Docket No. 99-200, FCC No. 01-362, paragraph 64 states that, "States may not accommodate requests for specific numbers (i.e. vanity numbers), but may grant requests for

customers seeking contiguous blocks of numbers." AT&T submits that University Hospitals' request constitutes special circumstances and demonstrates a clear requirement that warrants the Ohio Commission's review and reversal of NeuStar's decision.

Attached to this request are copies of AT&T Ohio's Thousand Block Application Form, the Months-to-Exhaust Certification, a copy of NeuStar's denial, and a copy of University Hospitals' request.

For the reasons set forth herein, AT&T Ohio respectfully requests that the Commission overturn NeuStar's denial and direct NeuStar to assign the requested numbers in the Terrace rate center to AT&T Ohio for use by University Hospitals.

Instructions for filling out each Section of the Part 1A form:

- Section 1.1 Contact information requires that Service Providers supply under "Block Applicant" the company name, company headquarters address, a contact within the company, an address where the contact person may be reached, in addition to the correct phone, fax, and e-mail address. The Pooling Administrator section also requires the Service Provider to fill in the Pooling Administrator's name, address, phone, fax and e-mail.
- Service Providers who need a thousands-block assignment or for an Location Routing Number (LRN) are required to fill in this section. If needed for an LRN, a CO Code Application needs to also be submitted to the PA. The Service Provider should supply the Numbering Plan Area (NPA); the Local Access Transport Area (LATA), which is a three-digit number that can be found in the TelcordiaTM LERGTM Routing Guide. The Operating Company Number (OCN) assigned to the service provider and the OCN its parent company. An OCN is a four-character alphanumeric assigned by TelcordiaTM Routing Administration (TRA). In addition, the number of thousands-blocks requested should be supplied. The Switch Identification as well as the city or wire center name, rate center, rate center sub zone, homing tandem and CLLITM tandem of the facilities based provider^{ix}. This letter documents our requirements in relation to additional numbering resources. It is understood AT&T may take this request to the state commission, if needed, to fulfill our request.

University Hospitals is expanding to multiple locations in the geographic area covered by area code 216. University Hospitals' has purchased another building located at 20800 Harvard, Beachwood, OH, already has multiple other sites in the same geographic area, and will likely continue to expand in that area. In order to provide to provide administrative, physician offices, research, administrative, lab space and other system services with phone services at the 20800 Harvard and surrounding locations, and to streamline our dial plan in preparation for conversion to central trunking, we require a consecutive block of 2000 DID's. Conversion to central trunking will result in a significant positive financial impact to the hospital system.

To meet the needs of our dial plan we are requesting that the prefix end in the digit 8. (The phone system will not accept a block of DIDs with a prefix starting with a 0, 1 or 9, i.e., 216-Nx8-xxxx). The numbers will be installed as DID's on new PRI's to be installed at 20800 Harvard Rd. This is an urgent request, as we need to install that PRI during the 2nd week of December 2014 to meet occupancy deadlines. Installation of these PRIs along with provision of 2000 DID numbers was originally requested on September 23, 2014. We expect that this block will meet our requirements for at least the next two years. We do not anticipate returning any numbers to AT&T.

AT&T is our service provider and we understand that they might escalate this request to the state utility commission.
