
**MEMORANDUM IN SUPPORT**

IEU-Ohio has filed the Direct Testimony of Kevin M. Murray in an unredacted form and under seal. By this motion, IEU-Ohio requests that the Commission issue an order that provides that the unredacted testimony remain under seal. The Ohio Power Company ("AEP-Ohio") has designated information contained in portions of the testimony as confidential and competitively sensitive and produced the information subject to a protective agreement between AEP-Ohio and IEU-Ohio. IEU-Ohio has filed a redacted version of this testimony separately and has endeavored to redact at the minimal amount necessary to assure compliance with its agreement with AEP-Ohio. IEU-Ohio takes no position as to whether the redacted information may be nonpublic information under Ohio law, but files this Motion for Protective Order and Memorandum in Support pursuant to a protective agreement executed by IEU-Ohio and AEP-Ohio.

WHEREFORE, IEU-Ohio respectfully requests that this Motion for Protective Order be granted for the reasons set forth herein.


