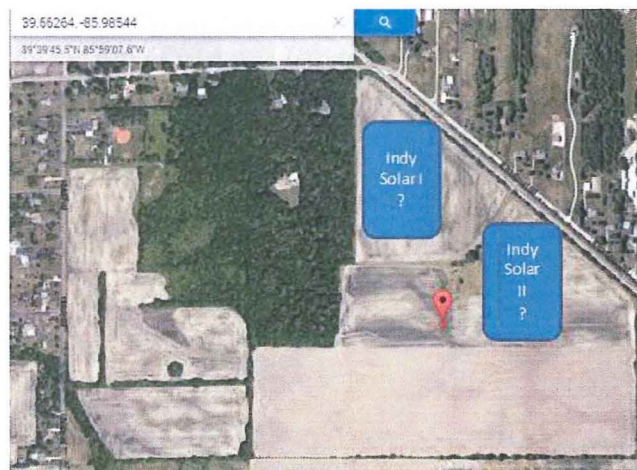
Dear Mr. Bellamy:

Indianapolis Power & Light Company has received your inquiry regarding the October 28, 2014, Indy Solar II LLC Application for Certification as an Eligible Ohio Renewable Energy Resource Generating Facility and respectfully submits the following response:

Question 1: In section I.a the nameplate capacity is listed as 10 MW. The nameplate capacity is section I.a should be listed in DC. But in section G.1 you state the facility has 43,170 300W panels. Since $43,170 \times 300W = 13,851,000W$ or 13.851 MW. Is the nameplate capacity (DC) 13.851 MW?

Answer 1: Yes. The DC nameplate capacity of the facility is 13.851 MW ($46,170 \times 300W$); and the AC nameplate capacity is 10 MW.

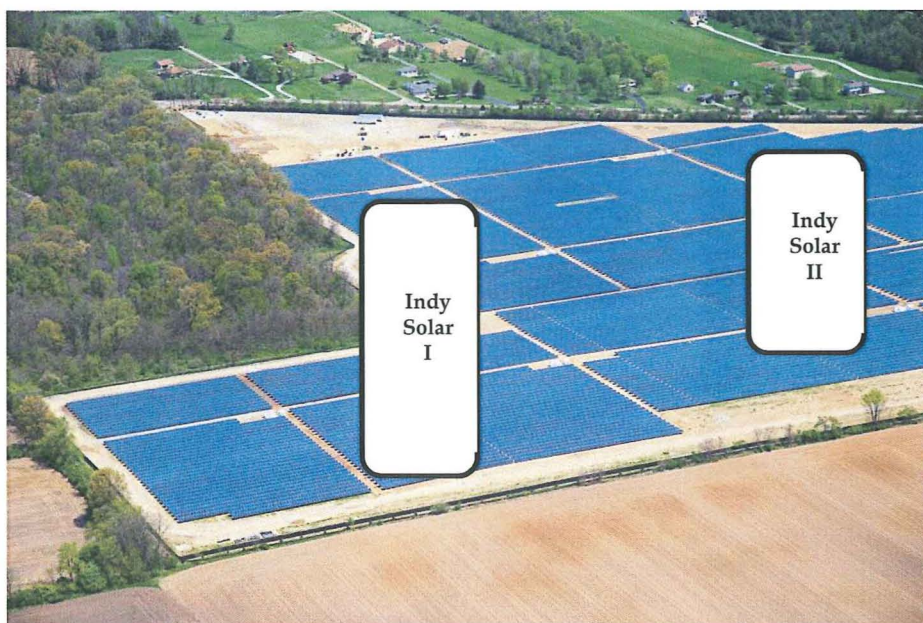
Question 2: Please indicate on an aerial image like the one below the locations of the Indy I and Indy II solar facilities.

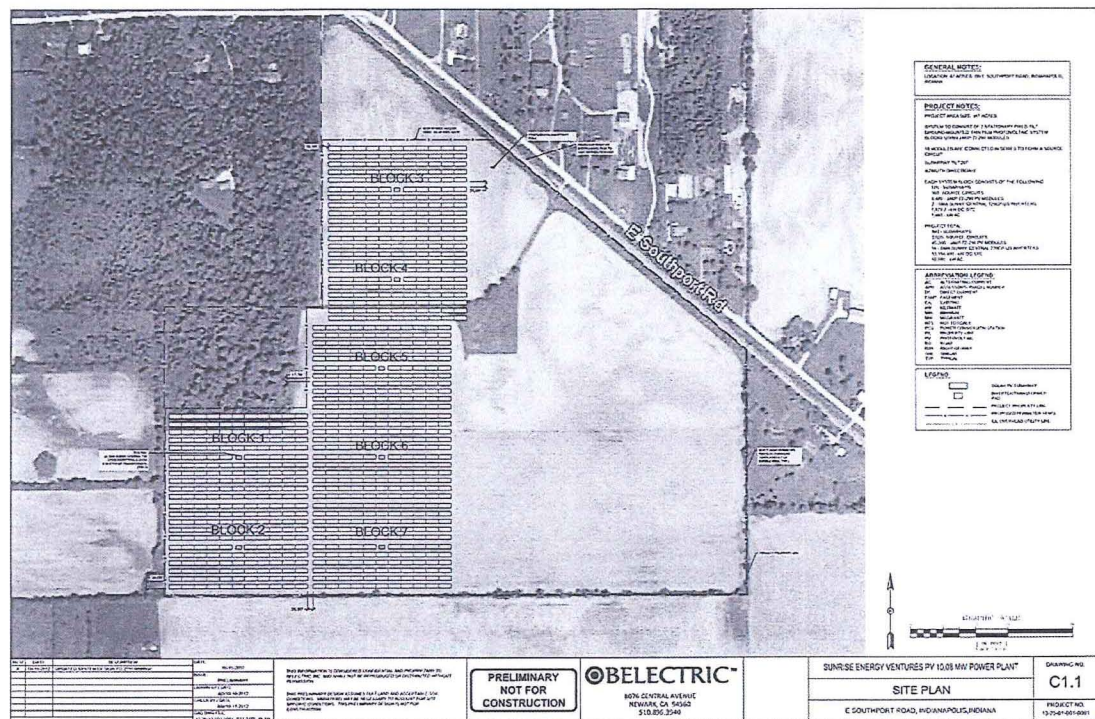

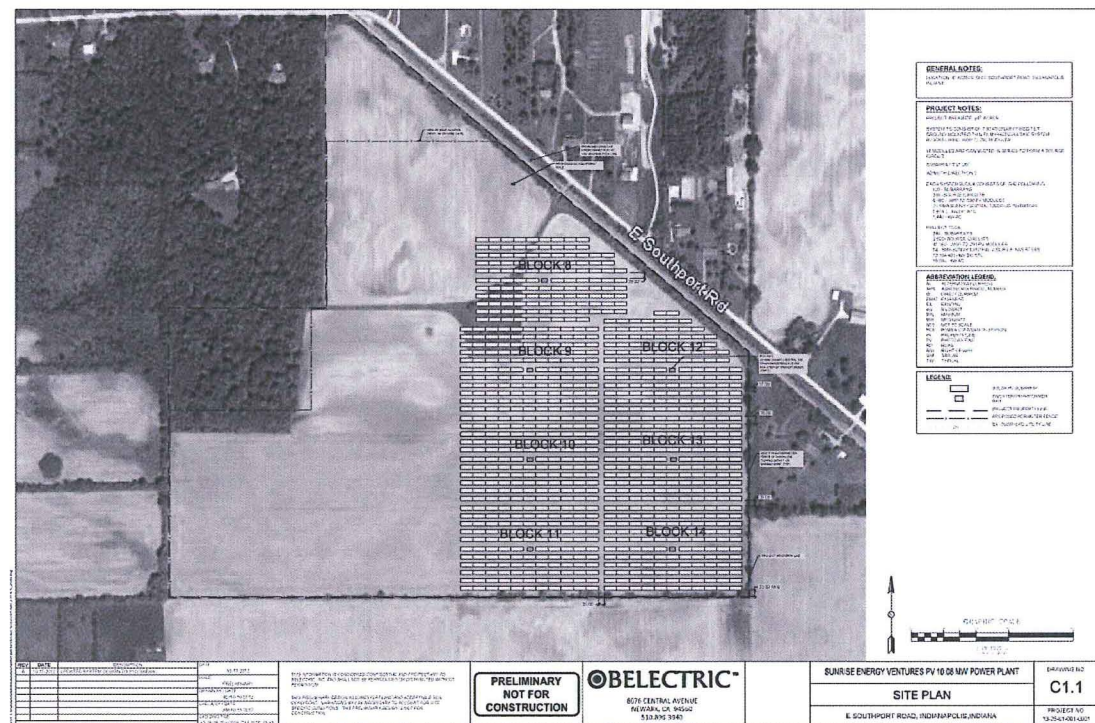
