## ENTRY

The Commission, coming now to consider the above-entitled matters, makes the following findings:

- The Commission Order issued January 18, 1977 in Case No. 76-622-WS-COI ordered existing water and sewer utilities under Commission jurisdiction to file amended tariffs reflecting the provisions of Sections 4901:1-15-09 through 14 of the Ohio Administrative Code and to fully comply with these sections by June 1, 1977.
- On June 2, 1977 the Applicant filed with the Commission three copies each of four revised sheets to make the company's water tariff PUCO No. 1 conform with the Commission's Opinion and Order rendered in Case No. 76-622-WS-COI. These amended tariffs were filed under the above styled Case No. 77-1164-WW-ATA.
- 3. The Commission Order issued August 1, 1977 in the above styled Case No. 77-83-WW-AAC stated that the Applicant's proposed tariffs as well as its existing tariffs must conform to revised Chapter 4901:1-15 Ohio Administrative Code. The Commission ordered the Applicant to file two complete sets of amended tariffs for Commission review and approval by Entry.
- 4. On September 29, 1977 three copies of the tariff sheets were filed which contained additional changes recommended by the Staff to make the tariffs comply more fully with the requirements of the Commission Order in Case No. 76-622-WS-COI.
- 5. After reviewing the Applicant's amended tariff sheets filed September 29, 1977 the Commission is of the opinion and so finds that the water tariff conforms with the provisions of the Opinion and Order issued in Case No. 76-622-WS-COI.

It is, therefore,

ORDERED, That the Applicant's tariff sheets as filed in Case No. 77-1164-WW-ATA be and hereby are approved. It is, further,

ORDERED, That with the approval of these tariff sheets, Arrowhead Hills Utilities Corporation has complied with the Order in Case No. 77-83-WW-AAC, and therefore said proceeding is hereby closed of record. It is, further,

ORDERED, That nothing herein contained shall be deemed to be binding upon the Commission in any subsequent investigation or proceeding involving the justness or reasonableness of any rate, charge, rule or regulation. It is, further,

ORDERED, That a copy of this Entry be served upon applicant and all other parties of record.
