Now comes Power Brokers, LLC, (“PBLLC”), and moves the Public Utilities Commission of Ohio (“Commission”) to grant an extension of the November 16, 2014 expiration date of its Certificate as a competitive retail electric service (“CRES”) provider. Through inadvertence, PBLLC did not file its application for renewal of Certificate No. 10-298E (2) within the 30 to 120-day advance timeframe, as required by Ohio Administrative Code (“OAC”) Rule 4901:1-27-09. PBLLC filed its application, out of time, October 31, 2014 and PBLLC seeks an extension of its Certificate’s expiration date while the Commission considers this Motion and reviews its application for renewal.

MEMORANDUM IN SUPPORT

PBLLC was originally granted the authority to operate as a CRES, effective October 28, 2010, and renewed on November 16, 2012. The current expiration date of PBLLC' CRES certificate is therefore November 16, 2014. In preparing its application for renewal of its certificate, PBLLC inadvertently lost sight of the fact that the Commission's rules require the submission of that application at least 30 days before the expiration date of the certificate. PBLLC's renewal application was filed on October 31, 2014.

With the lone exception of its oversight of the proper time for filing its application for a renewal of its CRES certificate, PBLLC is otherwise in good standing with this Commission and has done nothing that would warrant the suspension or rescission of its authority to serve as a CRES. Granting this Motion while the Commission considers PBLLC's renewal application is in the public interest.

WHEREFORE, Power Brokers, LLC asks the Commission for an extension of its certificate until December 1, 2014, or until such time as Power Broker, LLC's application for renewal of its certificate becomes effective.
