1 **I. INTRODUCTION AND PURPOSE OF TESTIMONY**

2 **Q. Please introduce yourself.**

3 A. My name is Joseph Haugen and I am employed by Interstate Gas Supply, Inc
4 d/b/a IGS Energy ("IGS"). I am Senior Power Supply and Schedule Analyst. I
5 have responsibilities related to IGS's power supply and risk. I am also
6 responsible for representing IGS in the PJM Interconnection, Inc. stakeholder
7 process and supervising IGS's demand response programs. My business
8 address is 6100 Emerald Parkway, Dublin, Ohio 43016. I have worked at IGS
9 since February 2013.

10 **Q. Please describe your educational background and work history.**

11 A. I graduated from the Ohio State University in 2005 with a B.A. I obtained a
12 Master of Business Administration from Otterbein University in 2009. Prior to
13 working at IGS, I was an energy scheduler for Buckeye Power from 2007 through
14 2013. I forecasted and scheduled daily power usage for the 25 cooperatives in
15 Ohio, and coordinated generation resources including wind, natural gas, and coal
16 plants. I performed statistical analysis for contract negotiations including future
17 load and price forecasting. I was also responsible for operating the demand
18 response program. Prior to that I was a Laboratory Manager for CTL
19 Engineering from 2005 to 2007.

20 **Q. Are you familiar with the testimony of Tim Hamilton?**

21 A. Yes, I have been involved in these proceedings for several months. I was part of
22 the IGS team that reviewed Duke's application and Duke's responses to

1 discovery submitted by various parties. My main focus, however, has been on
2 Duke's request for approval of the Price Stability Rider ("PSR"). Thus, I am well-
3 situated to adopt the prefiled testimony of Tim Hamilton, which is related to the
4 PSR.

5 **Q. Do you have any changes to the testimony you are adopting?**

6 A. No, I do not. I am adopting Mr. Hamilton's testimony in its entirety.

7 **Q. Does this conclude your testimony?**

8 A. Yes it does.
