Dear Resident or Property Owner,

A local public hearing, pursuant to Section 4906.08(C), of the Ohio Revised Code ("ORC") for the proposed Biers Run-Hopetown-Delano 138-kV Transmission Line Project will be held on Tuesday, December 16, 2014, at 6:00pm, at the Pioneer School of Developmental Disabilities, 11268 County Road 550, Chillicothe, Ohio, 45601. At this local public hearing, the Ohio Power Siting Board ("OPSB") shall accept written or oral testimony from any person. AEP Ohio Transmission Company ("AEP Ohio Transco") invites all residents and property owners who wish to present written or oral testimony, to attend this public hearing.

An adjudicatory hearing will commence on Tuesday, January 6, 2014, at 10:00am, 11th floor, Hearing Room 11-D, at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215-3793. This hearing is open to the public, but participation is limited to parties in the case as defined by ORC §4906.08.

AEP Ohio Transco has filed an application for a "Certificate of Environmental Compatibility and Public Need" for this project with the OPSB. This application has been assigned Case Number 13-0429-EL-BTX. Section 4906.07 of the ORC provides that: upon the receipt of an application, complying with Section 4906.06 of the ORC, the power siting board shall promptly fix a date for a public hearing thereon not less than 60 or more than 90 days after such receipt and shall conclude the proceeding as expeditiously as practicable. Pursuant to this rule and as previously stated within this letter, this hearing has been scheduled.

AEP Ohio Transco has published a notice in a Ross County area newspaper, the *Chillicothe Gazette*, announcing a local public hearing for a proposed major utility facility. The notice provides the time, date and place of the local public hearing, as well as, information about AEP Ohio Transco's plans to construct a new high voltage transmission line in the Chillicothe area in Ross County.

In addition to the notice of a local public hearing – this was published in the *Chillicothe Gazette* – we are sending this letter to each property owner and affected tenant within the immediate area of the proposed transmission line as required by Ohio Administrative Code ("OAC") Rule 4906-5-08(C)(3). A second public notice or reminder newspaper advertisement notice will be published in the same newspaper in December 2014 according to OAC Rule 4906-5-08(C)(2).

The Biers Run-Hopetown-Delano Transmission Line Project will extend from the Biers Run Substation to the existing Delano Substation, passing through the proposed Hopetown Substation, a proposed distribution substation that will replace the existing Camp Sherman Substation. The Biers Run-Hopetown-Delano Line will be approximately 11 miles long depending on the route selected, and will be located in Ross County. The Line will likely run primarily through Union Township with a short section in Green Township.

The Biers Run-Hopetown-Delano 138-kV Transmission Line Project is part of the overall Biers Run Project. The Biers Run Project is a major transmission reinforcement effort to help AEP Ohio maintain transmission reliability in south central Ohio. The total project will allow the company to address reliability concerns, potential low voltages and potential thermal overloads.

Three 138-kV transmission lines provide electric service to the Chillicothe and Circleville areas. Simultaneous outages on any two of these lines could affect electric supply throughout the area. Further, electric demand in Ross, Pickaway and surrounding counties is straining the existing transmission infrastructure. In addition to strengthening the grid, this Project will support future growth in the region.

Copies of the actual siting application, including specific details about the location and construction, are available for public inspection at the following locations: Chillicothe and Ross County Public Library and the Ohio Power Siting Board - Public Utilities Commission of Ohio. An electronic version of the siting application can be found at the Ohio Power Siting Board website at <http://opsb.ohio.gov>. Search under current cases for Case Number 13-0429-EL-BTX.

The following local city and county government officials have been served with a copy of the application as required by state of Ohio Power Siting Board regulations: Ross County Commissioners, Ross County Engineer, Green Township Trustees and Union Township Trustees. The state power siting board has served the following state agencies with copies of the application: Public Utilities Commission of Ohio, Ohio Department of Agriculture, Ohio Department of Development, Ohio Department of Health, Ohio Department of Natural Resources, Ohio Department of Transportation, Ohio Environmental Protection Agency and the Ohio Historical Society.

In conclusion and to reiterate, the local public hearing will be held on Tuesday, December 16, 2014, at 6:00pm, at the Pioneer School of Developmental Disabilities, 11268 County Road 550, Chillicothe, Ohio, 45601, where the OPSB shall accept written or oral testimony from any person. The OPSB will consider comments from the public and the OPSB Staff Report when evaluating the application.
