The attorney examiner finds:

- (1) On November 13, 2014, Indiana Eastern Railroad, LLC dba Ohio South Central Railroad (OSCR) filed a request to temporarily downgrade the warning devices from electric flashers to crossbucks at State Route 93 (SR 93) near Oak Hill, Ohio. OSCR explains that the tracks at that location are out of service until new customers can be found and the line can be rehabilitated. OSCR adds that when the new customers are found and the track is rehabilitated, new lights and gates will be installed with the approval of the Commission, as well as the Ohio Rail Development Commission (ORDC), which is taking ownership of the line.
- (2) Before proceeding further with this request, the attorney examiner observes that it is unclear from the request filed by OSCR as to which crossing(s) at SR 93 near Oak Hill OSCR seeks the downgrade. Therefore, OSCR shall file, by November 26, 2014, supplemental information indicating the U.S. Department of Transportation (DOT) number, milepost number, or street name of the crossing(s) for which it desires the aforementioned downgrade and serve a copy of its request and the supplemental information upon Oak Hill. Oak Hill and any other interested person may file any comments on the request by December 15, 2014. Staff should file an investigative report on the request by December 22, 2014.

It is, therefore,

ORDERED, That by November 26, 2014, OSCR file supplemental information specifying the DOT number, milepost number, and street name of the crossing(s), at SR 93 for which it seeks the downgrade and serve a copy of that information upon Oak Hill. It is, further,
