

## **MEMORANDUM IN SUPPORT**

On November 11, 2014, Diversegy, LLC (“Diversegy”) filed a Motion for Extension of its Certificate, requesting an extension until December 30, 2014. Pursuant Ohio Administrative Code 4901:1-24(A),<sup>1</sup> Diversegy’s Motion was automatically approved. Accordingly, Diversegy had until November 30, 2014, within which to file its Renewal Application. On December 10, 2014, Diversegy filed its Renewal Application—providing the Commission with less than thirty (30) days to approve the application.

Rule 4901:1-24-09(B) provides, in pertinent part:

(B) Any renewal application filed fewer than thirty calendar days prior to the expiration date indicated on the certificate, but no later than the expiration date on the certificate, shall be filed with a motion requesting an extension of the certificate. If the motion is filed in conformance with rule 4901:1-24-07 or 4901:1-24-13 of the Administrative Code, it shall be deemed automatically approved unless, within three business days of its filing, the commission or an attorney examiner appointed by the commission rules otherwise.


Diversegy’s Renewal Application was not filed with an accompanying Motion for Extension. Accordingly, Diversegy hereby requests an extension of its Certificate No. 12-605E(1), until January 10, 2015. This extension will provide the Commission with the requisite thirty (30) days within which to approve the Renewal Application.
