**MOTION FOR PERMISSION FOR JACOB BOUKNIGHT TO APPEAR  
*PRO HAC VICE* BEFORE THE COMMISSION**

Pursuant to Gov. Bar R. XII, Ohio Power Company hereby moves the Public Utilities Commission of Ohio (the “Commission”) to grant Jacob Bouknight permission to appear *pro hac vice* and participate as co-counsel in the above-captioned proceeding.

The following is a list of jurisdictions in which Mr. Bouknight has ever been licensed to practice law, including dates of admission to practice, resignation, or retirement, and any attorney registration numbers:

- i) North Carolina, Bar No. 420, Admitted August 1, 1968
- ii) District of Columbia, Bar No. 17441, Admitted July 10, 1973

Mr. Bouknight has not been granted permission to appear *pro hac vice* in more than three proceedings before Ohio tribunals in the current calendar year pursuant to Gov. Bar R. XII(2)(A)(5).



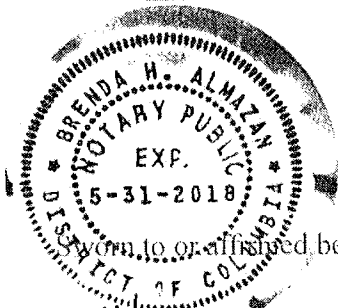
