Staff Interrogatories – Initial Set

Question 1: The application notes in section G.10g that the projected annual gross generation is 263 MWh, however, the projected gross annual generation given in section I.1 is 164 MWh. Please provide corrected information for Section G.10g and/or Section I.1 (including projected gross annual generation, as well as expected annual capacity factor % if applicable) that addresses the discrepancy.

Answer 1: <It should be only 164 MWh as the projected gross annual generation in section G.10g. The 263 MWh was initially calculated as the the total capacity if 100% efficient, but we later determined that was not realistic. I must have forgot to update that section. >

Question 2: The application indicates in section G.1 that the biogas is used in a “Capstone MicroTurbine C30(65kw),” however, in sections I.a and I.1 the unit nameplate capacity given is 30.00 kW and 0.03 MW. Please provide corrected information for these sections that addresses the discrepancy.

Answer 2: <This should be a Capstone Microturbine C30 (30kw). I kept flipping between the two applications and must have gotten it confused.>

Question 3: In section N.1.e, the meter reading given is 0. Please explain why the meter shows no recorded generation. Are both the facility and meter operational?

Answer 3: <The generator was initially installed on 3/27/14 and no meter was installed at that time. However it broke down this fall, I believe sometime in September 2014. The meter was installed while the generator was broke down and we were waiting on parts to arrive (in October 2014). The picture was taken after the meter was installed, before the generator was started up again. The generator has now been repaired and both the generator and meter are currently operational. If you need me to send a new picture of the meter I can.>
