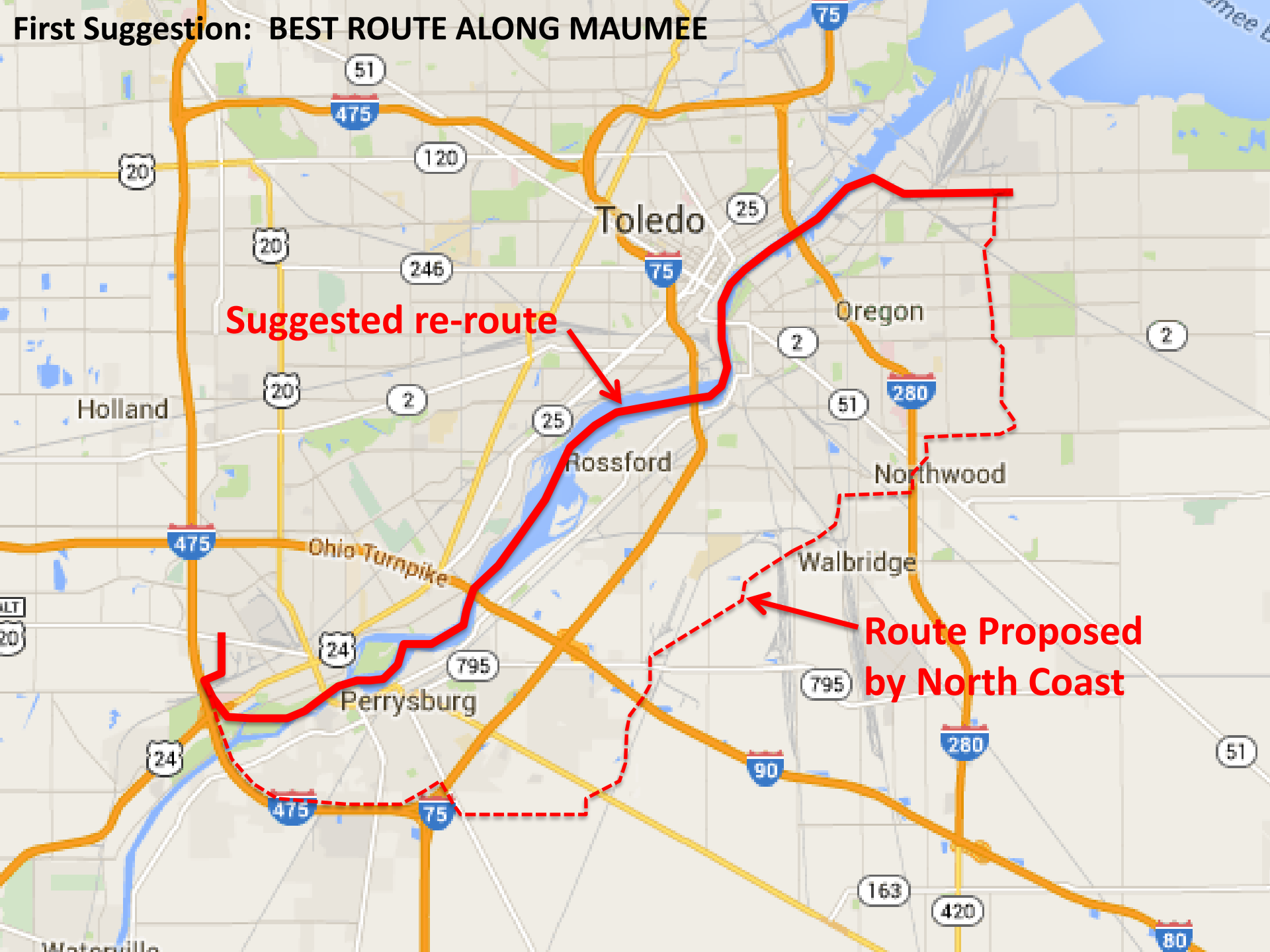
We are presenting 2 possible reroutes for the pipeline.

Our first suggestion is the most sensible.

Gas pipelines have been routed under oceans, seas and rivers throughout the world. The most direct route from Maumee to the Oregon Energy Center is up the Maumee River. It will not run over school property near children. It will not run close to homes. It will not ruin farmers' fields. It will not ruin homeowners' backyards. It will not devastate the investment local people have made in their own property. It would not be run near rock quarries where blasting is done. It would not be run near landfills. Moreover, it would require less pipe for NCGT. In areas where there is river dredging, place the pipe deeper and closer to the side of the river. It is also as safe, if not safer, than placing the pipeline on land.

Bottom line: Run it up the Maumee, then take the rail tracks over to the energy center. It's the BEST route.

First Suggestion: BEST ROUTE ALONG MAUMEE



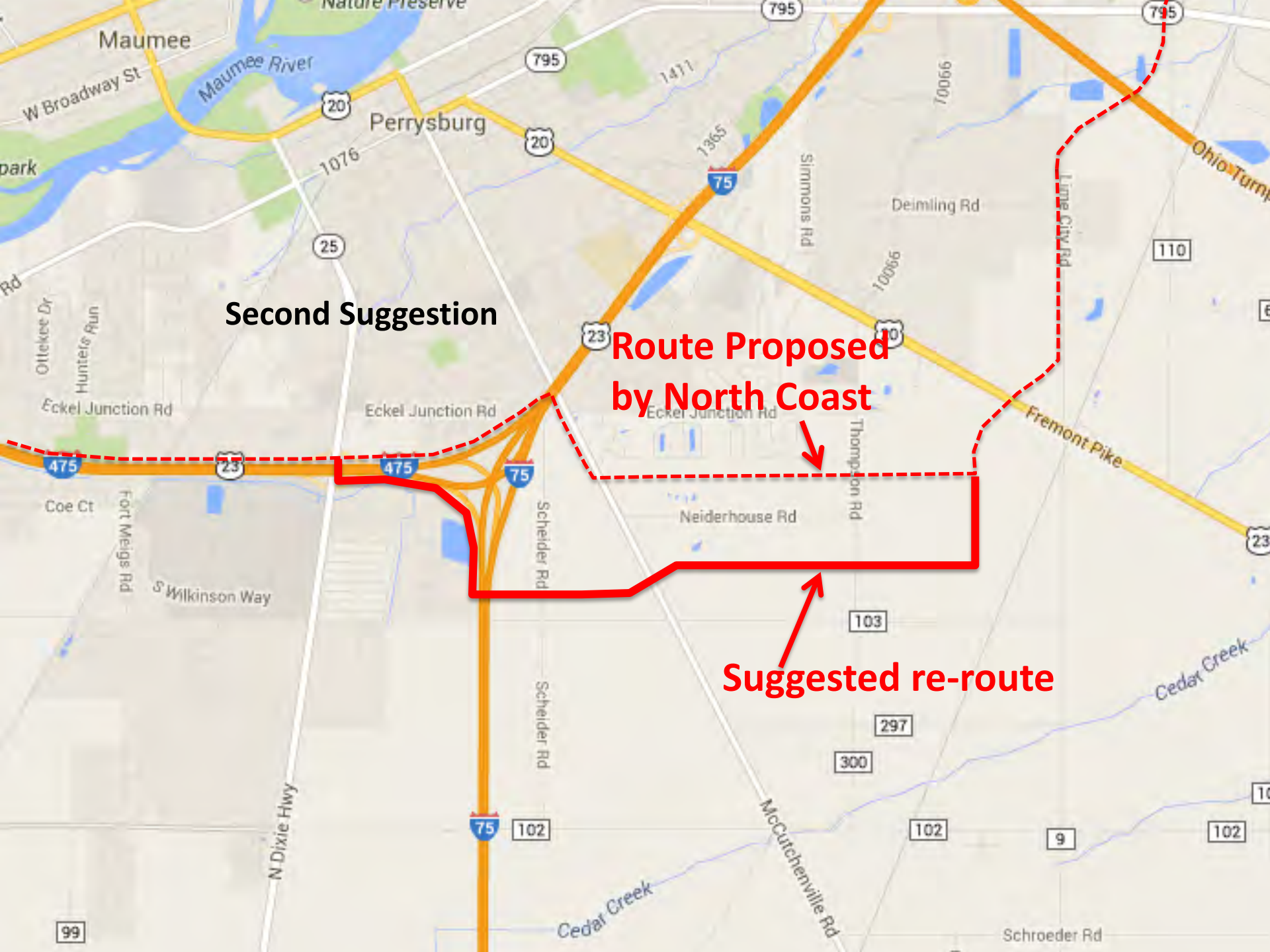
Suggested re-route

We are also including a second suggestion for rerouting of the pipeline. Personally, we do not like this re-route but, at least, the pipeline would not run under a ~600-foot transmission tower near homes. It would not be too close to homes nor run through school property used by children. It would run along property lines when possible.

However, we strongly suggest that you use our first suggestion because we are not satisfied with running the pipeline near the rock quarry by Lime City Road, nor cutting diagonally through marketable properties in Perrysburg Township or Oregon, nor ruining farmers' lands.
