DESCRIPTION OF THE TRANSACTION

Pursuant to Ohio Administrative Code § 4901:1-6-29, approval is hereby requested for the *pro forma* transfer of control of BCE Nexxia Corporation ("BCE Nexxia") to BCE U.S. Corporation ("BCE US"). As part of an internal corporate restructuring, BCE Holding Corporation ("BCE Holding") will merge into BCE US, which will become the new direct parent company of the certificated entity, BCE Nexxia. BCE Holding and BCE US are both currently indirect, whollyowned subsidiaries of BCE Inc., the ultimate parent of BCE Nexxia.

Although there will be a change in control of BCE Nexxia's direct parent company, ultimate control of BCE Nexxia will not change and will remain with BCE Inc. BCE Nexxia will remain the holder of and continue to provide facilities-based and resold interexchange telecommunications in Ohio under its Certificate of Public Convenience and Necessity ("CPCN"). The *pro forma* transfer of control will be seamless for Ohio customers. There will be no transfer of customers and no customer impact.

DESCRIPTION OF APPLICANTS

BCE Nexxia is a private Delaware corporation with executive headquarters at 1821 Walden Office Square, Suite 400, Schaumburg, IL 60173. BCE Nexxia is authorized to provide facilities-based and resold competitive local exchange and interexchange services pursuant to its CPCN, Number 90-6162 issued by the Commission on November 12, 2003.

BCE US is a private Nevada corporation with executive headquarters at 1821 Walden Office Square, Suite 400, Schaumburg, IL 60173. It is a holding company and does not have any operations in Ohio, nor does it plan to commence services in the state.

APPROVAL OF THE *PRO FORMA* TRANSFER OF CONTROL IS IN THE PUBLIC INTEREST

BCE Nexxia and BCE US respectfully submit that the *pro forma* transfer of control described herein will serve the public interest. The proposed restructuring transaction will not disrupt or negatively alter customer service, rates, or quality standards. As a result of the restructuring, there will be no change in the ultimate control of BCE Nexxia. Also, BCE Nexxia will retain its current CPCN and continue its operations in the same manner that it does today. Thus, the

public interest will be served by a seamless transaction that enables BCE Nexxia to continue providing service to Ohio customers. Moreover, as a wholly-owned subsidiary of BCE Inc., whose qualifications are a matter of Commission record, BCE US is managerially, technically, and financially well-qualified to complete the transaction.




