MOTION FOR PERMISSION FOR MATTHEW S. MCKENZIE TO APPEAR PRO HAC VICE BEFORE THE COMMISSION

Pursuant to Rule XII of the Supreme Court Rules for the Government of the Bar of Ohio,
Ohio Power Company hereby moves the Public Utilities Commission of Ohio (the
"Commission") to grant Matthew S. McKenzie (PHV-5903-2014) permission to appear *pro hac*vice and participate as co-counsel in the above-captioned proceeding.

Steven T. Nourse (#0046705), an attorney licensed to practice in the State of Ohio in good standing, has agreed to associate with Mr. McKenzie in this proceeding.

Attached are a copy of the certificate of *pro hac vice* registration for Mr. McKenzie furnished by the Supreme Court of Ohio Office of Attorney Services, a copy of the affidavit required by Gov. Bar R. XII(2)(A)(6), and a certificate indicating service of this Motion on all known parties and attorneys of record.

Mr. McKenzie understands that, if this Motion is granted, he must file a Notice of Permission to Appear *Pro Hac Vice* and a copy of the Order granting permission with the Office of Attorney Services within thirty days of the Order.
