ATTORNEY EXAMINER SEE: Scheduled
for today at almost this time is Case No.
05-376-EL-UNC entitled in the matter of
the application of Columbus Southern Power
Company and Ohio Power Company for authority to
recover costs associated with the ultimate
construction and operation of an integrated
gasification combined cycle electric generation
facility.

My name is Greta See and sitting
next to me is Sarah Parrot. We are the Attorney
Examiners assigned to this case by
the Commission.

I understand that the parties are
continuing to negotiate a possible resolution of
this case; is that correct?

MR. MCNAMEE: Yes, it is, your
Honor. The parties have had extensive
discussions among themselves, and I believe that
we have come to an agreement in principle that
has to be memorialized into a final stipulation.

We have not done that as yet, though

1 we expect to have a draft of that sometime
2 today.

3 So, I would suggest that calling
4 this matter and continuing it for at least a few
5 days will allow us to complete the resolution of
6 the matter. We are looking at a complete
7 resolution of the case.

8 And I will keep the Bench informed
9 about the progress of this. I hope that it will
10 proceed very quickly, indeed.

11 ATTORNEY EXAMINER SEE: And
12 the Bench agrees with that. I would ask that
13 the parties determine a date amongst themselves
14 that might be convenient for all of us to
15 reconvene, and that you let the Bench know. Is
16 there anything further?

17 MR. MCNAMEE: Well, that no members
18 of the public showed up, if that matters.

19 ATTORNEY EXAMINER SEE: Are there
20 any members of the public present that wish to
21 make a statement?

22 Let the record reflect that there
23 are no members of the public present.

24 And we will take appearances once we
25 reconvene. Thank you. The matter is adjourned

1 until further notice.
