

AMENDMENT NO. 1

TO THE INTERCONNECTION AGREEMENT FOR THE STATE OF OHIO

BETWEEN

UNITED TELEPHONE COMPANY OF OHIO
d/b/a CENTURYLINK

AND

TELEPORT COMMUNICATIONS AMERICA, LLC

Amendment No. 1 is entered into by and between United Telephone Company of Ohio d/b/a CenturyLink ("CenturyLink"), and Teleport Communications America, LLC ("CLEC"). CenturyLink and CLEC are collectively referred herein as the "Parties".

BACKGROUND:

WHEREAS, the Parties entered into an Interconnection Agreement for the state of Ohio ("Agreement") January 7, 2015.

WHEREAS, the Parties wish to amend the Agreement to update and replace the dedicated transport route to the Table One price sheet for Lima to Wooster, and the associated DS1 and DS3 rates for this route.

In consideration of the promises and agreements contained in this Amendment, the Parties hereby agree as follows:

AMENDMENT:

1. This Amendment updates and replaces the Lima to Wooster dedicated transport route and associated DS1 and DS3 rates in the Interconnection Agreement Table One price as follows:

2. Except as modified herein, the terms and conditions of the Parties Agreement shall continue in full force and effect. In the event of a conflict between the rates for the DS1 and DS3 Dedicated Interoffice Transport routes for Lima to Wooster in the Agreement and this Amendment, this Amendment shall control.
3. This Amendment No. 1 is executed by authorized representatives of CenturyLink and CLEC is made a part of and incorporates the terms and conditions of the Agreement.
