7	reflect this is the deposition of
8	Richard Fox and that it's being taken
9	pursuant to Notice and I guess you also
10	got a subpoena, I suppose

12	MR. EVANS: to make it formal. It is
13	being taken in the matter pending before
14	the Public Utilities Commission
15	involving the potential closing of the
16	CSX grade crossing at Crawford Morrow
17	County Line Road.
18	EXAMINATION OF RICHARD FOX
19	BY MR. EVANS:
20	Q Just for the record, Mr. Fox, will you state
21	your full name just for the record?
22	A Richard G. Fox.
23	Q As you can see, Mr. Fox, the testimony that
24	you're giving today is being taken down by the
25	court reporter. I'll be asking you a very

1		small series of questions really. You'll
2		recall I'm sure that you made comments or
3		provided some testimony, also sworn testimony
4		at the public hearing or one of the public
5		hearings held on this matter and I think we
6		briefly met that night. Our purpose here
7		today is primarily to follow up, ask you a few
8		more questions in depth that we're allowed
9		through this proceeding that we can do now,
10		but we couldn't do then. In terms of the
11		deposition it's a question and answer session.
12		I will ask questions and you can give an
13		answer if you have one if you know. I'll try
14		not to talk over you and you try not to talk
15		over me and it makes our court reporter's job
16		much easier. If any question is not clear or
17		if for some reason you don't hear the
18		question, let me know that and I'll restate it
19		or somehow fix the problem.
20	А	Okay.
21	Q	You have to respond verbally. She can't take
22		down nods of the head and actually uh-huhs and
23		huh-uhs don't translate well in writing. If

19		moment ago as your white cement driveway that
20		comes off the County Line Road and leads back
21		to your residence?

25	A	No, I actually I have a gentleman that helps

2		week that helps me, but I actually cut the hay
3		and bale it myself and he helps me with the
4		cattle.
5	Q	Are you otherwise employed?
6	A	Yes.
7	Q	What do you do?
8	A .	I'm a plant manager at Covert Manufacturing.
9	Q	Is it C-o-v-e-r-t?
10	A	Yes.
11	Q	It's on your shirt?
12	A	Yes.
13	Q	I've heard of them. Are they located in that
14		general area?
15	A	Yeah, here in Galion, yeah.
16	Q	We appreciate you coming over here I assume on
17		a lunch break or something from your regular
18		job. If I recall just in some of the
19		conversations we had or at least I was present
20		for after it was in conjunction with the
21		public hearing, it might have been right
22		after, I believe I recall you or your wife
23		indicating that you have I think it was two
24		sons?
25	A	Three. We have three.

11		concern for you?
12	A	Well, yes, I agree. You're always concerned
13		about them driving, but yes, it's a
14		concern.
15	Q	I think you've indicated that in the time that
16		you've lived there you're not aware of any
17		grade crossing accident, motor vehicle train
18		accidents that have occurred at that
19		particular crossing near your house?
20	A	That's correct.
21	Q	But having said that I assume you're a
22		licensed driver yourself; correct?
23	А	Uh-huh.
24	Q	You have to say yes or no?
25	А	Yes, I am.

2		various grade crossings in and around Galion
3		and elsewhere; correct?

8		than some other crossings?
9	A	Yes, I would.
10	Q	If you're coming from east to west on the
11		County Line Road there is sort of a mound or
12		small hill in the earth that kind of blocks
13		your view of the tracks until you kind of make
14	]	that last turn before going across?
15	A	Yes.
16	Q	And coming from either direction you're kind
17		of paralleling the tracks if there would be a
18		train coming behind you it's hard for you to
19		see?

21	Q	Then there is I think it's been measured
22		around 52, 53 feet gap between one set of
23	i	tracks to the other set of tracks?
24	A	There is a gap there, yes.
25	Q	Did you ever have occasion you or to your

3		the middle?

5		incident a few years ago some kids actually
6		got their car on the tracks there messing
7		around there.
8	Q	It got stuck somehow?
9	A	Yeah, I don't know if they decided to go down
10		the tracks or whatever. Later I was asked to
11		go to court on a DUI matter on that, but I
12		think it was resolved before it went to court.
13	Q	So the record is completely clear, the DUI did
14		not involve you, it involved the kids?

16	Q	Having said that, we've talked a little bit
17		about what some of the challenges a motor
18		vehicle driver is presented with at this
19		crossing, but having lived there as long as
20		you have and based upon your understanding of
21		the lack of accident history, I assume you
22		would agree if a driver is paying attention
23		and being careful that you can safely
24		negotiate that crossing?

1	Q	Your family has done it despite whatever
2		worries you had about your teenage kids and
3		whatever?
4	А	Yes.
5	Q	Now, so I'm picking up on and asking a few
6		questions about a couple of concerns as I
7		understood you had based upon the testimony
8		that you provided previously at the public
9		hearing?
10	А	Okay.
11	Q	One of those concerns I think was fire or EMS
12		response time; correct?
13	A	Correct.
14	Q	I know you testified that for one reason or
15		another in the past they've been to your
16		property I think your recollection was twice?
17	A	Twice, yes.
18	Q	And if I represent to you which I am that Fire
19		Chief Jackson from Galion actually was sitting
20		in that chair an hour or so ago and testified
21		about routes to this location and alternate
22		routes to this location and if I ask you to
23		assume that he testified from his knowledge
24		and experience as fire chief that he would not
25		have any concern from the standpoint of being



1		adequately and timely to respond to a
2		situation at your residence, would that or
3		does that at least in part allay any of your
4		concerns in that regard?
5	А	You know, I believe that they can. I believe
6		they can get to my house. I think maybe one
7		of the concerns that we had was we had an area
8		down the road this way. We have some bad
9		drifts from time to time that might be an
10		issue for the Fire Department at the right
11		time of year, but you know, the only other
12		concern I had is naturally these are tighter
13		intersections at Taylor Road and Monnett New
14		Winchester where it connected. I think a fire
15		truck coming at rescue speed is a different
16		intersection, one to negotiate than the one
17		down at 309 and 61 which is wide and plenty of
18		visibility.
19	Q	The Chief testified and of course, his
20		testimony will speak for itself and stand
21		separate and apart from anything that I say.

separate and apart from anything that I say. First of all he testified in responding to addresses on the County Line Road that would be west of you that they would typically go out -- I'll have to find the road, Galion New

Winchester Road and which would intersect with 1 2 Taylor and Iberia and several other roads and 3 the typical route so folks living west of you living on County Line Road would be from that 4 5 direction either down Taylor or down one of 6 those other roadways depending where the 7 address was? 8 Α Yes. 9 In terms of your concerns with respect to the 0 10 route that would involve ultimately coming 11 down Taylor and making a left to your house, 12 if the Chief feels that's a route that can be 13 taken, does that at least again in part allay 14 some of your concerns about that? 15 Α Yeah, and I would think today if I was a 16 fireman that's the way I would come. I come home from work a lot because the tracks are 17 1.8 blocked by the railroad, but that's the way I 19 learned to come home. 20 The Chief agreed with I think the route that Q 21if we assume for the moment this crossing was 22 closed, they then had to come to your residence they would come down 309 to --23 Monnett New Winchester. 24 Α To Taylor and left down to your residence? 25 Q

2	Q	One of the advantages you have there you're
3		not dealing with any grade crossing to get
4		there?
5	A	Okay.
6	Q	In terms of whether it's a stopped train or
7		moving train temporarily blocking the
8		crossing, if from your knowledge of the
9		territory would you agree that route would not
10		involve a grade crossing whereas the one
11		coming along County Line Road?
12	A	A grade crossing is a railroad crossing?
13	Q	Yes.
14	А	Yes, I would agree. What I mentioned before
15		the things that concern me are the actual road
16		crossings. They're not the widest roads, but
17		as far as staying away from the railroad I
18		agree with you, that makes sense to me.
19	Q	If the Chief feels in terms of his trucks and
20		fire trucks he could negotiate those corners
21		that are north and west of the tracks then you
22		would be satisfied with that?
23	A	Absolutely.
24	Q	Okay. One of your other concerns was as a
25		farmer and having to do so you grow hay?



1	A	Uh-huh.
2	Q	Is that for use with your livestock or is some
3		of it sold?
4	A	We probably use a third of it and sometimes
5		two-thirds of it.
6	Q	I'm not a farmer. I don't know exactly when
7		the hay gets planted and when you harvest it.
8		Is it a certain time of year?
9	A	We try to get three cuttings a year and our
10		hay is not planted every year. It's something
11		that continues to come up just like grass in
12		your yard. So you know, my concern was that
13		when we have somebody come in we make a
14		five-foot diameter, four-foot wide bales, some
15		guys would pick up I think what the most I put
16		on a big trailer would probably be between 15
17		and 20 bales. They like to get the most they
18		can when they come and legal to haul.
19	Q	When they come in to pick up, are folks
20		picking up this hay that they would take and
21		resell or are they taking it up for their own
22		use?
23	А	I think it's mostly their own use.
24	Q	So are these other farmers purchasing your
25		hay?

1	A	Uh-huh.
2	Q	You have to say yes?
3	А	Yes, I'm sorry.
4	Q	It's common. So what types of trucks do they
5		tend to come in with to pick that up?
6	A	Most of them are like a big souped up pickup
7		trucks, one ton pulling a trailer with it.
8	Q	They're pulling a trailer and some of the hay
9		may go in the bed of the pickup truck?
10	A	Most of them go on the gooseneck trailer, but
11		they need a fairly heavy trailer to pull that.
12	Q	What I'm impressed with when I go out there I
13		guess that's a cement driveway?
14	A	Yes.
15	Q	I'm assuming they don't drive down your cement
16		driveway?
17	A	They do, yes.
18	Q	That shows you what I know. Is there
19		somewhere there they turn around?
20	А	Down behind our barn is where we keep our hay
21		and there is a place they can turn around and
22		we load them and they come straight and out.
23	Q	They would be pulling in head first into your
24		driveway and be able to turn around and
25		they're coming out head first onto the
	1	



1		roadway?
2	A	Yes.
3	Q	Your concern with respect to the movement of
4		those trucks or trailers attached to the
5		pickup trucks more of it goes back to some of
6		the other corners down at Taylor Road and some
7		other location perhaps where you're just
8		wondering if it would be just be as easy for
9		them to negotiate those?
10	A	That's correct.
11	Q	Once they get to your property whether they
12		we're assuming the crossing is open, if
13		they're coming from east to west on County
14	l	Line Road they would go across the crossing
15		and need to make that right turn into your
16		driveway; correct?
17	А	That is correct.
18	Q	If they're coming down County Line Road it's a
19		bit of a left just because of the curve in the
20		road it's a little closer to a straight line
21		in your drive?
22	A	That's correct.
23	Q	Are there also farms located I'm sorry, did
24		you want to add something?
25	A	No.

1	Q	Are there also farms located west of you along
2		County Line Road?
3	A	Well, I know there is a farm. You know,
4		there's a gentleman Mike Kocher that farms all
5		of this ground which would be on the south
6		side of County Line Road.
7	Q	Between that and the tracks?
8	A	Yeah, and I know that they farm a little
9		further past Taylor Road. There are farm
10		fields on the north side also and then from
11		there up to out to all the way out to Route
12		100 there are farms on both sides.
13	Q	Do you have any idea what you said the fellow
14		Kocher?
15	A	Mike Kocher.
16	Q	Do you know what he usually farms there?
17	А	Between corn, beans and wheat. He usually
18		puts one of the three in.
19	Q	Does he own the property or lease it?
20	A	Actually I think Dick Beck still owns that
21		ground and he leases it all to Mike Kocher.
22	Q	Any idea how many acres he has?
23	A	No, I hate to tell you. I think this farm it
24		goes down quite a ways. So I never heard how
25		many acres that is.

1	Q	You said there are some other farms down past
2		Taylor Road and on out to 100 I guess?
3	A	Yes.
4	Q	Any idea what kind of farming they did?
5	А	It's mostly grain farming. Like I said, it's
6		between corn, grain and wheat.
7	Q	Would those farms excluding Mr. Kocher's
8		operation here be similar to yours in the
9		sense they would have somebody coming in at
10		harvest time and trucks let me finish that
11		question, and trucks to pick up the harvest?
12	A	Yes.
13	Q	In your case it sounds like it's often pickup
14		trucks and trailers. I've certainly seen big
15		farming operations where you're talking about
16		a semi?
17	А	I know Mike uses semis and I've seen them down
18		the road. So yeah, this farming from here
19		down probably uses a little larger equipment.
20		Yes, I agree with that.
21	Q	Again, I'm not a farmer. My understanding
22		when semis are involved they typically when
23		they come in they will actually go out into or
24		onto some portion of the field where they get
25		loaded and are able then to kind of turn
	l I

1		around and able to pull back out onto the
2		roadway?
3	A	I would agree. Of course, that is weather
4		optional, but when the ground is hard and they
5		could get in there they like to get in the
6		field. I've seen the trucks parked at New
7		Winchester and they auger it out from the
8		field into the semi.
9	Q	I guess it's not your operation obviously so,
10		you know, I wouldn't expect you to have a lot
11		of information on it, but to the extent that
12		these farms that are, for example, west of
13		Taylor Road going onto 100 grain farms or
14		whatever else is out there, the semis that are
15		getting to those locations to help them load
16		the harvest they're getting there somehow off
17		of those roads out there?
18	А	Yes, I agree they're doing it now.
19	Q	Let's see if I have anything else here to ask
20		you. I know you testified I believe at the
21		public hearing I heard some statements you
22		made both on the record at the public hearing
23		and perhaps, you know, before or after the
24		public hearing. So I won't necessarily say
25		for sure you were talking about this on the



1		record. I think you're aware of a pipeline
2		that runs underneath your property?
3	А	That's correct.
4	Q	And what pipeline well, was that pipeline
5		there when you bought the property?
6	A	Yes.
7	Q	So it's been there at least 25 years that
8		you've owned the property?
9	А	Yes.
10	Q	Similarly just along that same line when you
11		bought the property it was already a farm and
12		a farmhouse; correct?
13	A	Yes.
14	Q	And you've improved upon that I can tell, but
15		these tracks that were here that we're talking
16		about were also there when you bought the
17		property?
18	A	Yes.
19	Q	The pipeline was there, you can see it on
20		Exhibit 1 to your deposition. This little
21		square area kind of directly across from your
22		driveway I understand to be some type of
23		substation, I'll use that term, related to the
24		pipeline, is that your understanding?
25	A	Yes, that natural gas pipeline comes at this



1		angle right here and I'm going to say ten, 15
2		years ago they put a power generating plant
3		off of South Street down in Galion. This is
4		the tap for that generating plant and they ran
5		the pipe down along the tracks and across and
6		over and feeds that power generating plant.
7	Q	Just so you're pointing, I want the record to
8		kind of try to indicate what you just said.
9		The main pipeline, if you will, or the
10		original pipeline that passes through your
11		property kind of goes roughly from the bottom
12		left corner of Exhibit 1 up to where the
13		substation is located and then up onto your
14		property?
15	A	That's correct. From this one, that pipeline
16		is laying just misses our as a matter of
17		fact, it just goes right behind our sugar
18		shack and right down through. You used to be
19		able to see well, I think this is the
20		right-of-way right here. You can see they
21		keep that clear through the property that
22		straight line. So that gas line is running
23		just about like that.

Let's go ahead and mark this Exhibit 2 to your



1		deposition.
2		(Fox Exhibit 2, was marked for
3		identification.)
4	Q	What I marked as Exhibit 2 to your deposition
5		another aerial photograph. You'll agree with
6		me it shows the same area of Exhibit 1, but
7		taken from a higher vantage point?
8	А	Yes.




