In the Joint Stipulation and Recommendation (Joint Ex. 1) adopted and approved by the Commission in its February 11, 2015 Order on Remand in Case No. 05-276-EL-UNC, Ohio Power Company (AEP Ohio) agreed to refund to its customers through one-time bill credits certain amounts specified in the Stipulation. AEP Ohio committed in the Stipulation to return those amounts to customers, as described and supported by AEP Ohio witness Andrea E. Moore's direct testimony (AEP Ohio Ex. 4), during the first billing month following the Commission's final order adopting the Stipulation without material modification.

Enclosed are original Sheet No. 498-1 (IGCC Credit Rider) and Original Sheet No. 498-1D (Open Access Distribution – IGCC Credit Rider) to Tariff P.U.C.O. No. 20, which will implement AEP Ohio's commitment.
