ENTRY

The attorney examiner finds:

- (1) On December 22, 2014, Solvay Advanced Polymers, L.L.C., dba Solvay Specialty Polymers (Solvay), and Kraton Polymers U.S. LLC (Kraton) filed these applications, pursuant to Ohio Adm.Code 4901:1-39-05(G), to integrate the installation of their respective combined heat and power (CHP) systems with the peak demand reduction, demand response, and energy efficiency (EEDR) programs of Ohio Power Company (AEP or utility). Both applications were subject to the 60-day automatic approval process under the pilot program adopted by the Commission in Case No. 10-834-EL-POR (EEC Pilot) unless suspended by order of the Commission or attorney examiner.
- (2) On February 20, 2015, an Entry was issued suspending the 60-day automatic approval under the EEC Pilot program for both applications, and granting intervention to Industrial Energy Users-Ohio and Ohio Manufacturers' Association Energy Group in both proceedings.
- (3) As these applications do not appear to involve any dispute as to the material facts contained therein, but do raise novel issues with respect to the integration of their CHP systems under 2012 Am.Sub.S.B. No. 315 and 2014 Sub.S.B. No. 310, no evidentiary hearing of these matters will be conducted. The parties are, however, directed to file comments by April 13, 2015, regarding the policy issues to be considered by the Commission in these cases. Any reply comments should be filed by April 27, 2015.

It is, therefore,

ORDERED, That the parties file any comments regarding the policy issues to be addressed in these cases by April 13, 2015, and reply comments by April 27, 2015. It is, further,

ORDERED, That a copy of this Entry be served upon each party of record.
