MOTION FOR CONTINUANCE OF HEARING DATE

NRG Ohio Pipeline Company LLC (“NRG” or “Applicant”) respectfully moves the Ohio Power Siting (“Board”) or its Administrative Law Judge for a continuance in accordance with Ohio Administrative Code (“OAC”) Rule 4906-7-13(A) so that the adjudicatory hearing currently scheduled for April 14, 2015 at 10:00 a.m., at the offices of the Public Utilities Commission of Ohio can be rescheduled to April 23, 2015.

MEMORANDUM IN SUPPORT

NRG filed its application in the above referenced matter on December 19, 2014. On March 9, 2015, the Board issued an Entry scheduling a hearing for April 14, 2015. Due to the unavailability of Applicant’s key witnesses on April 14, 2015, NRG is requesting a continuance of the adjudicatory hearing to April 23, 2015.

No party will be prejudiced by granting this motion. The Board Staff along with each of the intervening parties do not object to the continuance. Under these circumstances and pursuant to OAC Rule 4906-7-13(A), it is reasonable and just for the Board or its Administrative Law

Judge to grant this continuance and re-schedule the adjudicatory hearing in this matter for April 23, 2015.

WHEREFORE, NRG requests the Board or its Administrative Law Judge to grant a continuance of the scheduled adjudicatory hearing until April 23, 2015.
