In accordance with Ohio Adm. Code 4901-1-12 and 4901-1-13, Aqua Ohio, Inc. (Aqua or the Company) respectfully requests an extension of time to file a responsive pleading in this case until March 27, 2015. Good cause exists to grant this motion, which is detailed below.

On March 2, 2015, the Complainant filed his complaint. Investigating the complaint's factual allegations has required Aqua to coordinate with various employees in different departments. Despite the Company's best efforts, this investigation will not be completed in time to allow an answer to be filed on the due date of March 23, 2015.
