Thank you for contacting the Ohio Power Siting Board regarding NRG Ohio Pipeline Company's proposal to construct a pipeline in Lorain County. I will file your remarks below in the public comments for case number <u>14-1717-GA-BLN</u>. I understand that your mother, Mary B. Miller, is participating in this case as a property owner intervenor.

On March 9, 2015, the Board suspended NRG's application in order for the Board and its staff to further review this case. The Board held a local hearing in Elyria on April 8 and will conduct an adjudicatory hearing in Columbus on April 23. Once the adjudicatory process is complete, the Board will schedule the project for a decision at a later date.
