**Resolution of the PUC Ohio EDI Working Group (OEWG)
April 14, 2015**

The Ohio EDI Working Group (OEWG) is comprised of Ohio's electric distribution utilities and certified retail electric suppliers, marketers, and other interested stakeholders. OEWG has developed uniform business practices and electronic data interchange (EDI) standards for the electric industry to allow customers to choose generation service from alternative suppliers in Ohio. The Commission adopted Ohio EDI Implementation Guideline transaction sets in Case No. [00-813-EL-EDI](#) in its [July 19, 2000 Finding and Order](#), at 17-18, and approved revisions to the Implementation Guidelines in Case Nos. [12-1770-EL-EDI](#) and [13-0002-EL-EDI](#).

The OEWG has established a change control process that is open to all market participants and accessible on the [OEWG page of the Commission's website](#). The change control process maintains current redline versions of the Ohio EDI Implementation Guidelines on the OEWG page. The OEWG has incorporated all approved changes from the 2013-2014 period into a new version of the EDI Implementation Guidelines to be submitted for Commission approval.

On March 31, 2015, the following EDI Implementation Guideline transaction sets were filed in the above-captioned case by Brandon Siegel, Co-Chair and Change Control Manager of the Ohio EDI Working Group (OEWG) to update Ohio's electric industry EDI documentation:
