## **Description of the Changes**

In this filing, Benton Ridge Telephone Company increases its BLES rate and related maximum residential local rate by \$1.25 per month in its Benton Ridge, New Bavaria, and North Creek exchanges, effective June 1, 2015. The residential rate will increase from \$17.55 to \$18.80. No other rates will be increased at this time.

Benton Ridge Telephone Company received BLES pricing flexibility, effective June 1, 2013, in Case No. 13-0998-TP-BLS. Its most recent increase in residential local rates was effective on June 1, 2014.

## Customer Notice and Affidavit

The following customer notice will appear on bills that are mailed to customers on May 1, 2015. Effective June 1, 2015, our local telephone rate for residential customers will increase by \$1.25 per month, from \$17.55 to \$18.80. This increase is due to Federal Communications Commission ("FCC") rules. Many rural telephone companies, including ours, receive support from the Federal Universal Service Fund. The FCC's rules will reduce our support if our local rates are below the national average. This \$1.25 increase is required to bring our local rates more in line with the national average.
