There is one question that I would like to ask the "powers that be" at the OPSB. Out of all the cases that have ever been presented for industrial wind facilities approval, what percentage have actually been denied as compared to those approved. Since the inception of this proposed wind facility here in Greenwich, there have been oversights exposed, not only on Windlab's part but on the part of OPSB as well. When these oversights were addressed, the answer we got was basically this " Oh don't worry about that, these things can be mitigated at a later date."! Of course, everyone starts to do the double shuffle repositioning themselves for more time to cover their tracks while the residents of Greenwich are expected to "toe the line".
