MOTION OF TIME WARNER CABLE INFORMATION SERVICES (OHIO), LLC FOR REVIEW OF A DECISION OF THE NORTH AMERICAN NUMBERING POOLING ADMINISTRATOR

Time Warner Cable Information Services (Ohio), LLC d/b/a Time Warner Cable ("TWCIS") is a certificated local exchange carrier providing service throughout Ohio. One of its customers, Reliable Runners Courier Service, Inc. of Mentor, Ohio is located in the MENTOR rate center and is in need of additional telephone numbers. Specifically, due to certain limitations in the customer's PBX, the customer requests 20 DID telephone numbers for which the last four digits would be 1XXX or 7XXX. TWCIS does not own any blocks of numbers that start with a one or seven in a Mentor rate center.

In response to its customer's need, TWCIS has recently made a Central Office Code (NXX) assignment request to the Pooling Administrator seeking a block of numbers for MENTOR rate center.

Attachment A is the request to the NIM Administrator for a need for a special number in the rate center of Mentor, Ohio consists of the Thousands-Block Application Form – Part 1A for tracking number 440-MENTOR-OH 830044 which was prepared by TWCIS and submitted to the Pooling Administrator.

TWCIS prepared and submitted to the Pooling Administrator its Months To Exhaust and Utilization Certification Work Sheet – TN level. See Attachment B.

TWCIS has submitted a request for the special block of 20 DID numbers to the Pooling Administrator which was denied on May 7, 2015. The explanation for the denial given was as follows:

DR-57: You do not meet the MTE and/or utilization requirements, therefore this request for a new block is denied. You may proceed with requesting a State Waiver from the appropriate state commission using this Part 3 denial. If you are in disagreement with the disposition of this request, please refer to the Thousands Block Number (NXX-X) Pooling Administration Guidelines for the appeals process.

Attachment D is a letter from Reliable Runners Courier Service, Inc. HMT requesting new DID numbers.

The Commission has authority to review the PAS decision and issue a waiver to PAS authorizing assignment of the NPA-NXXs requested by TWCIS.

Instructions for filling out each Section of the Part 1A form:

Section 1.1 Contact information requires that Service Providers supply under "Block Applicant" the company name, company headquarters address, a contact within the company, an address where the contact person may be reached, in addition to the correct phone, fax, and e-mail address. The Pooling Administrator section also requires the Service Provider to fill in the Pooling Administrator's name, address, phone, fax and e-mail.

Section 1.2 Service Providers who need a thousands-block assignment or for an Location Routing Number (LRN) are required to fill in this section. If needed for an LRN, a CO Code Application needs to also be submitted to the PA. The Service Provider should supply the Numbering Plan Area (NPA); the Local Access Transport Area (LATA), which is a three-digit number that can be found in the iconectiv M LERG M Routing Guide. The Operating Company Number (OCN) assigned to the service provider and the OCN its parent company. An OCN is a four-character alphanumeric assigned by iconectiv Telecom Routing Administration (TRA). In addition, the number of thousands-blocks requested should be supplied. The Switch Identification as well as the city or wire center name, rate center, rate center sub zone, homing tandem and CLLITM tandem of the facilities based provider M. Explanations of these terms may be found in the footnotes.

Section 1.3 The date the Service Provider completes the application should be entered in this section, as well as the Effective Date of the requested thousands-block.
