Dear Ms. McNeal:

The May 1, 2013 Opinion, Order, and Certificate approving Oregon Clean Energy, LLC's ("Oregon") Certificate of Environmental Compatibility and Public Need to Construct an Electric Generation Facility ("Certificate") and the March 15, 2013 Second Supplement to Application established a set of conditions and supplemental commitments as part of the Certificate.

Specifically, in part, **Commitment No. 20**, which included in the Second Supplement filed on March 15, 2013, requires that:

Prior to the commencement of construction activities that require permits or authorizations by federal or state laws and regulations, the Applicant will obtain and comply with such permits or authorizations. The Applicant will provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant. The Applicant will provide a schedule of construction activities and acquisition of corresponding permits for each activity at the preconstruction conference.

In compliance with Commitment No. 20, attached is a copy of the City of Oregon Site Drainage Plan Review and Permit.




PLANS, DRAWINGS & SPECIFICATIONS REQUIRED FOR PERMIT REVIEW AND APPROVAL

- Owner or Developer shall submit a detailed Site Drainage Plan with this permit application when plat of land is not already covered under an existing approved Site Drainage Plan. The Site Drainage Plan shall include all existing and proposed elevations of the property and indicate the basic storm-water drainage paths. (Sec; 1309 OCO)
- In areas without curbs, there shall be swales along the roadway not less than 6-inches below the road and a drive tile of not less than 12-inches shall be installed. Approved tile material shall depend on the amount of cover above pipe.
- All roof drains and downspouts shall terminate above grade and extend a minimum of 5-feet from the building. See OBOA Sec 803.1 and OPC 1101.2
- On-site detention or retention shall be required for all site improvements, excluding 1-family residential lots, in which the degree of impervious area (roofs, drives, etc.) is increased from pre-developed conditions. Detention volume shall be based on 5-year pre-developed outflow and 25-year post developed inflow, See OMC 1176.05.
- Storm sewers within the public right-of-way shall be sized for a 5-year storm frequency. Storm interceptors or ditches shall be sized for a 20-year storm frequency based on full and ultimate development. See OMC 1176.06 and 1974 Storm Drainage study for design information.
- Storm sewer construction shall be in accordance with current ODOT Construction Material Specifications.
- See "Storm Drainage Requirements for City of Oregon Improvements" dated July 7, 1998 for further information. Copy is available from Building & Zoning Inspection and Public Service Departments.

ACKNOWLEDGEMENT: As owner or the owner's authorized agent, in consideration of the granting of this permit, agree to save the City of Oregon harmless for any and all damages. I agree to do said work in all respects in compliance with the Statutes of the State of Ohio and Ordinances of the City of Oregon and to comply with the rules and regulations of the Director of Public Service or His agents. I agree to correct, at my own expense, any work resulting from any future improvement necessitating its removal.
