In accordance with Ohio Adm. Code 4901-1-12 and 4901-1-13, Aqua Ohio, Inc. (Aqua or the Company) respectfully requests an extension of time to file a responsive pleading in this case until July 10, 2015. Good cause exists to grant this motion, which is detailed below.
