Under this arrangement, AEP Energy has been selected as the Village of Coldwater's preferred electricity supply provider. This special offer is exclusive for eligible residents of the Village because through the power of volume buying, AEP Energy is able to secure electricity at competitive prices. AEP Energy is an Ohio-based company and a subsidiary of American Electric Power (AEP).

Through the Village Electric Aggregation Program, originally formed in September 2014, eligible residents, starting with the September 2015 billing cycle, depending on your meter-read date, will receive the price of 5.99 cents per kWh for a period of twenty-six (26) months.<sup>2</sup>

You will be automatically enrolled in the program unless you choose NOT to participate by "opting-out" by September 8, 2015. If you do NOT wish to participate in this program, you must follow the "opt-out" instructions. If you do not respond to this letter, the local utility will complete the enrollment process. As a part of the enrollment process, you will also receive a notice from your local utility, DP&L, confirming your decision to enroll with AEP Energy. Simply review the letter - if you are pleased with the Village Electric Aggregation Plan, then you are all set.

#### The Village Electric Aggregation Program is a Smart Choice:

- It's Easy to Participate. You don't have to do anything to enroll. All eligible residents will be automatically enrolled in the program unless you choose to "opt-out."

#### What is the Village Electric Aggregation Program?

Under the Village Electric Aggregation Program, the Village acted on behalf of its electricity consumers to select an electricity supply provider who, through the power of volume buying, is able to secure electricity at competitive prices. The Public Utilities Commission of Ohio ("PUCO") has taken steps to ensure that Ohio's competitive electricity environment is consumer-friendly. Voters in the Village approved this aggregation program and the Village Council passed an ordinance adopting this Electric Aggregation program.

The Village has selected AEP Energy as their preferred electricity supply provider to serve their residents beginning with the September 2015 billing cycle for a period of twenty-six (26) months.

#### Who is AEP Energy?

AEP Energy is a certified Competitive Retail Electric Service (CRES) provider and a subsidiary of American Electric Power Company, Inc. (AEP). With an office located in Columbus, Ohio, AEP Energy sells electricity supply to customers at market-based prices rather than regulated rates offered by your local utility.

#### How do I enroll?

You don't have to do anything to enroll. All eligible customers will be automatically included in the program unless you choose to "opt-out." If you "opt-out," you will continue to be served by your local electric utility's standard service offer or until you choose an alternative electric service provider. However, if you do not respond to this letter, the utility will complete the enrollment process. As a part of the enrollment process, you will also receive a notice from your local utility, DP&L, confirming your decision to enroll with AEP Energy. Simply review the letter - if you are pleased with the Village Electric Aggregation Plan, then you are all set. No deposits are required to enroll.

#### When will this program start?

The Village Electric Aggregation Program will begin with the September 2015 billing cycle.

#### What is my price?

The Village of Coldwater has ensured that, beginning with the September 2015 billing cycle, depending on your meter-read date, you will receive an electricity generation price of 5.99 cents per kWh for a period of twenty-six (26) months.

#### $\label{eq:lower_state} \mbox{How do I estimate my savings?}$

To estimate what your savings per kilowatt-hour (kWh) will be through this program, locate your 'Price to Compare' on your electricity bill. This is the price you pay for electric generation service from the utility. Take your 'Price to Compare' and subtract the offer price. This equates to your savings per kWh. Multiply your savings per kWh by your monthly usage (kWh) to determine your savings amount per month. The utility distribution and transmission charges and other utility charges and fees are not included in the savings calculation and will continue to be assessed by the local utility. (Any estimate of savings is not a guarantee of savings.)

#### Where do I send payment?

You will continue to receive one bill each month from your local utility. The amount that you owe to AEP Energy will be stated separately on your bill and you will continue to send payments to your local utility only.

#### Can I remain on budget billing?

Yes, you can remain on budget billing; however, the budget billing program does not apply to your charges from AEP Energy – only to charges from the electric utility. Your total charges from AEP Energy will fluctuate from month to month according to your usage.

#### Can I cancel at any time?

Yes, you may cancel without penalty and switch to another provider or revert back to DP&L, the local utility. Should you cancel your service with AEP Energy and return to standard offer service with your local utility, you may not be served under the same rates, terms, and conditions that apply to other utility customers.

#### What happens at the end of the program?

As the program draws to a close, the Village can choose to seek bids from electricity providers in order to negotiate a new contract on behalf of eligible households. If at that time, the program has not produced the savings originally anticipated for customers, the Village can also choose to end the program, at which time participants would be notified of their options for continuing in a different program with AEP Energy, switching to another provider, or reverting back to the local utility.

#### Why is this an "opt-out" program?

It enables AEP Energy to offer a lower group rate based on the Village's size.

#### Why did the Village select AEP Energy as its provider?

The Village selected AEP Energy because they were able to propose a program that represented the best overall value for eligible households.

#### If I opt-out initially, can I choose to join the program at a later date?

If you opt-out initially, unfortunately, you will not be able to join the program at a later date.

#### What happens if my family moves to another home?

If you move to another home location within the Village of Coldwater, you will be able to continue participating in the program. If you leave the Village of Coldwater, you will no longer be eligible to participate.

Unless you affirmatively "opt-out" by September 8, 2015, you will be automatically enrolled if you: a) have an eligible residence located in the specified city receiving electric service from DP&L or AEP Energy and b) are not enrolled in the PIPP program. Participation in the program is subject to the Terms & Conditions of the Agreement between the Village and AEP Energy. ¹Estimated savings apply to the generation service portion of your electricity bill and are based on an average residential customer, using 750 kWh of electricity on a monthly basis with a weighted average DP&L Price to Compare (PTC) rate of 9.728 as of August 2015 compared to our price of 5.99 cents per kWh. ²AEP Energy's price excludes utility distribution charges and other utility charges and fees.
