Pursuant to Ohio Administrative Code, Rule 4901:1-40-04(F)(5), this letter serves as notice to the Public Utilities Commission of Ohio that PPL Renewable Energy, LLC ("PPL Renewable"), the holder of renewable energy resource generating facility Certificate Number 10-SPV-PA-GATS-0617 for the PPL Crayola Solar facility (the "Crayola Facility"), and Certificate Number 12-SPV-PA-GATS-1345 for the ESLD Solar 1 facility and Certificate Number 12-SPV-PA-1346 for the ESLD Solar 2 facility (collectively, "ELSD Facilities") has changed its legal name to Talen Renewable Energy, LLC ("Talen Renewable").¹

In addition, the name of the Crayola Facility was changed to Talen Crayola Solar. The contact for both the Crayola Facility and the ESLD Facilities should be changed to Nick Pratt. 


