

On behalf of Ohio Environmental Council, Environmental Law & Policy Center, and Natural Resources Defense Council (collectively "Environmental Advocates"), we write to inform the Public Utilities Commission of Ohio that the Environmental Advocates elect not to file an Initial Post-Hearing Brief in the above referenced proceeding.
