In the matter of the authorization of CSX Transportation to install active grade crossing warning

devices in Bartlow Township, Henry County

September 8, 2015 Date:

The Ohio Rail Development Commission (ORDC) has authorized funding for CSX Transportation (CSX) to install mast-mounted flashing lights and roadway gates at the following locations in Bartlow Township, Henry County:

CR B, DOT# 155750P, approved cost \$237, 570.00 TR 3C, DOT# 155751W, approved cost \$380,027.00 CR C/Hartwell Ave, DOT# 155752D, approved cost \$398,016.00 TR A, DOT# 155749V, approved cost \$220,153.00

These crossings were surveyed on April 15, 2015. TR 3C had been the focus of closure negotiations by ORDC, but the Township desired to keep the crossing open. The other three crossings were priority picks due to hazard rank.

The projects will be paid for with federal funds, and are actual cost. As the plans and estimates for the projects have been submitted and approved, staff requests a Finding & Order with completion due in nine months. Construction may commence at once. Staff requests that the following language be incorporated in the Entry:

It is expected that all work necessary for FHWA acceptance of the warning devices will be completed by the in-service due date and that the railroad will be responsible for this work. This work includes, but is not limited to:

Any ancillary work to make the warning devices function as designed and visible to the roadway user, and

MUTCD compliance, including minor roadway work if necessary.

A suggested case coding and heading would be:

The Force Account Estimate dated 7/28/2015 for the referenced project(s) have been reviewed and are acceptable and the Proposed Crossing Layouts have been approved as to signal layout only. CSX Transportation may proceed with the construction of the proposed grade crossing warning system in accordance with the abbreviated plan. This authorization is made with the stipulation and understanding that the approved estimate may contain entries for items or activities that may be cited and found to be ineligible for federal participation during the project audit. Reimbursement of eligible actual cost is limited to a total of \$617,597.00 (\$237,570.00 for CR B, OH1063 plus \$380,027.00 for TR 3C, OH1064). Additional costs must be approved in writing by the Ohio Rail Development Commission (ORDC) prior to being incurred. Emergency verbal authorizations by ORDC may be permitted and will be confirmed by ORDC in writing within ten (10) business days of the verbal approval.
