- (1) By Entry issued on September 23, 2015, the Commission issued for comment proposed rules as part of Ohio Adm.Code Chapter 4901:1-6 to implement R.C. 4927.10 and 4927.101 as well as the amendments to existing R.C. 4927.01, 4927.02, 4927.07, and 4927.11 as required by Amended Substitute House Bill 64 (H.B. 64) of the 131st Ohio General Assembly. Initial and reply comments are due October 6 and October 20, 2015, respectively.
- (2) On September 24, 2015, counsel for the Ohio Telecom Association (OTA) filed a motion for extension of time to file comments and a memorandum in support. The OTA asserts that due to the complexity and importance of the issues addressed by H.B. 64, additional time is required so that the parties may be able to review and comment on the legal and policy issues raised by the proposed rules. Accordingly, the OTA requests that the due date for initial comments be extended to October 26, 2015, and reply comments to November 9, 2015.
- (3) The attorney examiner determines that good cause exists to grant the requested extension of time. Accordingly, the due date for initial comments shall be extended to October 26, 2015, and reply comments to November 9, 2015.

ORDERED, That all interested persons or entities wishing to file comments or reply comments with the Commission regarding the proposed rules do so no later than October 26, 2015, and November 9, 2015, respectively. It is, further,
