Mr. Brown,

Thank you for contacting the Ohio Power Siting Board (OPSB) regarding EverPower's planned Scioto Ridge Wind Farm. I have filed your comments in the online record for case numbers 13-1177-EL-BGN (<http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=13-1177>), 13-1767-EL-BSB (<http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=13-1767&x=0&y=0>), and 13-1768-EL-BTX (<http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=13-1768&x=0&y=0>). In these cases, the OPSB granted certificates to EverPower to construct the wind farm and related facilities.

An amendment to case number 13-1177-EL-BGN is currently pending before the OPSB in case number 14-1557-EL-BGA (<http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=141557&x=0&y=0>). In this application, EverPower proposes to relocate components of the facility including several wind turbine locations. A report filed by the OPSB staff on September 4, 2015 makes recommendations to the Board's 11 members. However, the final decision-making authority in this case rests with the Board.
