I received your letter of August 4, 2015 requesting verification of Dominion Retail, Inc.'s ("Dominion Retail") Ohio gross intrastate revenues reported in its 2014 Annual Report to the PUCO for use in determining the amount Dominion Retail is to be assessed for OCC's operation during FY2016. The letter contains the reported 2014 revenues for Dominion Retail's competitive retail electric business conducted under Certificate No. 00-008(E) and for its competitive retail natural gas business conducted under Certificate No. 02-018(G).

Although Dominion Retail continues to provide competitive retail natural gas service in Ohio, Dominion Retail ceased providing competitive retail gas service in Ohio during 2014, and Certificate No. 00-008(E) was cancelled by the PUCO, effective February 18, 2015, pursuant to Dominion Retail's application in Case No. 14-2111-EL-ABN. Accordingly, Dominion Retail is not required to pay the portion of its FY2016 OCC assessment that relates to its former competitive retail electric service business.

However, for the reason explained above, I have crossed out the information relating to Certificate No. 00-008(E).


