MOTION FOR SUBPOENA

Pursuant to Rule 4901-1-25, Ohio Administrative Code (“O.A.C”), Complainant, Orwell Natural Gas Company, moves the Public Utilities Commission of Ohio (“Commission”) respectfully request the issuance of a subpoena duces tecum, with expedited treatment, in the form attached as Exhibit “1,” commanding the attendance of non-party witness, Roger Sarver, 180 E. Broad Street, Columbus, Ohio 43215, at the hearing in the within matter scheduled for Tuesday, November 3, 2015 as may be continued and until discharged. As this Motion is filed no

later than five (5) days prior to the commencement of the hearing, 4901-1-25(A)(2), O.A.C.,
provides, in pertinent part:

The commission, any commissioner, the legal director, the deputy legal director, or an attorney examiner may issue subpoenas, upon their own motion or upon motion of any party. A subpoena shall command the person to whom it is directed to attend and give testimony at the time and place specified therein. A subpoena may also command such person to produce the books, papers, documents, or other tangible things described therein...

(2) To receive *expedited treatment* (emphasis added), a motion for a subpoena and the subpoena itself should first be submitted in person to the attorney examiner assigned to the case, or to the legal director or a designee, for signature of the subpoena. After the subpoena is signed, a copy of the motion for a subpoena and a copy of the signed subpoena shall then be filed with the docketing division by the requesting party and served upon the parties to the case. The person seeking the subpoena shall retain the original signed subpoena and make arrangements for its service.

Therefore, Complainants respectfully request that the Attorney Examiner grant, with expedited treatment, Complainant's request and forthwith issue the subpoena so that it may be timely served.
