62.1 <u>Uncollectible Expense Rider</u>. In addition to the above rates, a charge of \$0.0304 per Mcf will be applied to all gas consumed pursuant to this rate schedule to recover the cost associated with uncollectible accounts of those Customers subject to Uncollectible Expense Riders.
