OBJECTION TO REQUEST TO RESCHEDULE HEARING

The Ohio Bell Telephone Company d/b/a AT&T Ohio (“AT&T Ohio”) objects to Complainant’s Request for Reschedule filed November 4, 2015.

1. The Attorney Examiner has been more than accommodating to Complainant on discovery matters. A status conference to address discovery disputes was held on October 2, 2015, via teleconference. A few minutes into the hearing, Complainant abruptly hung up his telephone, thereby terminating the hearing.

2. At Complainant’s request, the Attorney Examiner scheduled another hearing via teleconference for October 27, 2015 to address discovery matters. Complainant failed to attend the hearing. Complainant did not notify either the Attorney Examiner or AT&T Ohio prior to the hearing of any scheduling problems.

3. Complainant’s request for a third hearing is unsupported. The request alludes to unspecified medical and health issues, but there is no showing that any such issues prevent Complainant from participating in scheduled hearings via teleconference, or from requesting a continuance prior to a hearing if circumstances warrant.

For these reason, AT&T Ohio respectfully requests that the Request for Reschedule be denied.
