Accompanying this letter are hard copies of an application to amend the Certificate of Environmental Compatibility and Public Need for Phase II of the Timber Road II Wind Farm, approved in Case No. 10-0369-EL-BGN as amended in Case No. 10-3128-EL-BGA (the "Certificate"). The application in this proceeding was electronically filed earlier today.

By order of the Ohio Power Siting Board in Case No. 10-3128-EL-BGA, the initial certificate was bifurcated into two phases, Phase I (held by Paulding Wind Farm II) and Phase II (held by Paulding Wind Farm III LLC). Phase I of the initial certificate has been constructed and is currently in operation. Phase I is located solely in Benton Township, Paulding County, Ohio. Phase II of the initial certificate and the subject of this proceeding will be located in Harrison Township, Paulding County, Ohio.

To avoid confusion in this proceeding between Phase I and Phase II of the Timber Road II Wind Farm, the Applicant will refer to Phase II of the Timber Road II Wind Farm as the "Timber Road III Wind Farm" throughout the application.


