No. 15-1288-GA-CSS being entitled In the Matter of  
Faye E. Daniels versus the East Ohio Gas Company,  
doing business as Dominion East Ohio.

7 I would just note for the record that our  
8 witness, Margaret Callahan, is here and is prepared  
9 to testify, although given the failure to appear of  
10 the Complainant, we will not be offering her  
11 testimony into the record today.

12 EXAMINER SEE: Okay. Mr. Campbell, would  
13 you like to make any motions at this time?

14 MR. CAMPBELL: Yes, we would, your Honor.  
15 We would move to dismiss the case for failure to  
16 prosecute, with prejudice.

17 EXAMINER SEE: Okay. Mr. Campbell, given  
18 that you've elected to make the motion to dismiss  
19 with prejudice, I will ask you to reduce your motion  
20 to writing.

21 Can you tell me when you would be able to  
22 file that motion?

23 MR. CAMPBELL: I think by close of  
24 business tomorrow we would be able to make that.

25 EXAMINER SEE: Okay. With that, I will

1 expect your motion by close of business tomorrow.  
2 Please send a courtesy copy to the Attorney Examiner  
3 as well as docketing.

4 Is there anything else?

5 MR. CAMPBELL: Nothing here. We will  
6 also serve it on the Complainant.

7 EXAMINER SEE: Of course.

8 If there is nothing else, this hearing is  
9 adjourned. Thank you.
