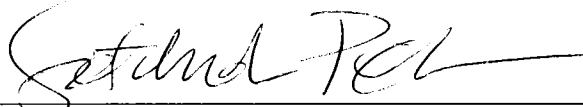

Mr. Allen shall bring documents, including but not limited to, his filed direct testimony in this proceeding, any documents relied upon or cited in his direct testimony, and any workpapers that support his direct testimony.
