REPLY TO GREENWICH NEIGHBORS UNITED’S FILING ON DECEMBER 29, 2015

On December 17, 2015, 6011 Greenwich Windpark, LLC (“Greenwich”) filed its Reply to Comments and Objections of Greenwich Neighbors United (“GNU”).¹ GNU filed a Response to 6011 Greenwich Windpark, LLC’s Reply on December 29, 2015 (“GNU’s Response”).

To the extent that GNU’s Response is a permissible filing, Greenwich now respectfully makes this reply to correct an erroneous procedural statement made in GNU’s Response. Greenwich does not further reply to the objections repeated in GNU’s Response, as these arguments remain outside of the scope of the amendment application proceeding and were addressed by Greenwich in its December 17, 2015 filing.

GNU states that Greenwich was “unauthorized” to include the following statement in the newspaper notice of the amendment application: “Affected persons may file comments or motions to intervene in this matter with the Board up to ten (10) days following the publication of this notice.”²

Pursuant to Ohio Revised Code Section 4906.06(E), Greenwich published a notice of the amendment application. Legal counsel for the Board approved the notice before it was

published. Counsel for Greenwich submitted a draft of the public notice for approval by the Board's legal counsel on November 12, 2015. The notice was approved by the Board's legal counsel on November 16, 2015. Greenwich then published the notice, as approved, in the *Norwalk Reflector* and the *Greenwich Enterprise Review* on November 20, 2015 and November 24, 2015, respectively. GNU is entirely incorrect to state that the notices were published without authorization by the Board.
