



NOTICE OF AMENDMENTS TO MAJOR UTILITY FACILITIES

Paulding Wind Farm LLC and Paulding Wind Farm III LLC have filed an application with the Ohio Power Siting Board in Case No. 15-2031-EL-BGA to amend the certificate of environmental compatibility and public need issued on August 23, 2010 in Case No. 09-980-EL-BGN for the Timber Road I Wind Farm. Paulding Wind Farm III LLC has filed an application with the Board in Case No. 15-2030-EL-BGA to amend the certificate of environmental compatibility and public need issued on November 18, 2010 in Case No. 10-0369-EL-BGN, as amended in Case No. 10-3128-EL-BGA, to construct Phase II of the Timber Road II Wind Farm. The Timber Road I Wind Farm and phase II of the Timber Road II Wind Farm will be located in Paulding County, Ohio. The purpose of the application to amend the certificate for the Timber Road II Wind Farm is to: (1) deliver electricity from the project to a different point of interconnect with the regional transmission grid; (2) propose an additional turbine model; (3) re-locate the collection substation; and (4) modify the access road and collection line system design. Likewise, the purpose of the application to amend the certificate for the Timber Road I Wind Farm is to: (1) deliver electricity from the project to a different point of interconnect with the regional transmission grid; (2) propose an additional turbine model; (3) re-locate the collection substation; and (4) modify the access road and collection line system design.
