I would like to commend you for denying the initial request by Duke Energy and AEP for a Purchase Power Agreement that would transfer costs of outdated and inefficient coal power plants to the citizens of Ohio. I would also like to encourage you to deny as similar request by First Energy. Your initial decision supports your mission as follows: (1) mandating the availability of adequate, safe and reliable utility service to all business, industrial and residential consumers; (2) ensuring financial integrity and service reliability in the Ohio utility industry; and (3) promoting utility infrastructure investment through appropriate regulatory policies and structures.

Protecting the safety of the citizens of Ohio includes reducing negative impacts energy sources have on our environmental and, thus, human health. 
