Dear Ms. McNeal,

Iron Energy understood that this notice was previously filed in July of 2015, but it has come to our attention that this was not the case. Therefore, pursuant to Rule 4901:1-24-11(B)(1) of the Ohio Administrative Code, I am notifying the Commission of a significant change in ownership of Iron Energy LLC d/b/a Kona Energy. The new owner is a wholly owned subsidiary or affiliate of Vantage Commodities Financial Services, LLC. Iron Energy LLC d/b/a Kona Energy will continue to hold Certificate No. 12-574E and will continue to provide competitive retail electric service in Ohio.


Ms. Kelley holds a degree in Art History from The University of Texas at Dallas.
