


Pursuant to authority granted under the Ohio Administrative Code, Ultimate Energy Advisors, LLC, (the "Company") is requesting an extension to its certification as a Competitive Aggregator/Retail Natural Gas Broker Certificate Number 14-342G(1) (the "Certificate") for purposes of renewing its Certificate.

Although the Company's Certificate has not yet expired, O.A.C. 4901:1-27-09(A) requires the Company to file an application for renewal thirty (30) to sixty (60) days prior to the Certificate's expiration date. When a renewal application would be filed fewer than thirty (30) days prior to an expiration date on the Certificate, a motion requesting an extension of the Certificate for the requisite time may be filed to make the renewal application timely. O.A.C. 3901:1-27-09(B). Motions shall be deemed automatically approved provided the motion is filed in conformance with O.A.C. 4901:1-27-07. O.A.C. 4901:1-27-07 provides that the motion must be filed by an attorney authorized to practice law in the state of Ohio.

Here, the Company's Certificate is set to expire on February 16, 2016. **As permitted by O.A.C. 4901:1-27-09(B), the Company is requesting to extend the Certificate by thirty-five (35) days. As a result, the Company's Certificate will expire on March 22, 2016.** As the Company is filing its application concurrently with this Motion, the application for renewal will be in the requisite thirty to sixty day renewal window. Furthermore, the Motion is being filed by the undersigned, an attorney authorized to practice law in the state of Ohio.

As the Motion complies with Ohio law, the Company respectfully requests that an extension of thirty-five (35) days be granted, making the Company's Certificate effective until on March 22, 2016.


