



Cops granted deposition delay

COLUMBUS, Ohio (AP) — Two policemen who confronted a man carrying an air rifle in a Wal-Mart will be allowed to postpone giving formal statements about the deadly police shooting in a lawsuit while a federal criminal investigation is pending.

The depositions of Beaver Creek police Officer Sean Williams and Sgt. David Darkow will be delayed at least three months under last week's ruling by U.S. Magistrate Judge Michael Newman.

Their attorneys argued the officers faced an "impossible" choice: give

statements that might contribute to a potential criminal case against them or invoke their constitutional right against self-incrimination and skip a chance to defend themselves in the civil matter. They argued it was in the interests of justice to postpone the depositions while the Department of Justice reviews whether civil rights violations occurred.

Newman granted a limited stay for 90 days, noting that it wouldn't delay key dates in the legal proceedings and attorneys could continue taking statements from other witnesses.
