JOINT APPLICATION TO ASSIGN SUBMITTED BY NORTH COAST GAS TRANSMISSION LLC AND GENERATION PIPELINE LLC

Pursuant to Chapter 4906.04 of the Ohio Revised Code, North Coast Gas Transmission LLC ("North Coast") and Generation Pipeline LLC ("Generation Pipeline"), collectively the "Joint Applicants," seek approval to assign the Certificate issued in Case No. 14-1754-GA-BLN for the Oregon Lateral Natural Gas Pipeline ("Oregon Lateral Pipeline") from North Coast to Generation Pipeline. In keeping with the policy of the State of Ohio, the pipeline will continue to be subject to the jurisdiction of the Ohio Power Siting Board ("the OPSB") and the terms and conditions prescribed in the OPSB Staff Report for the Oregon Lateral Pipeline docketed on December 29, 2014, as amended on January 5, 2015.

Generation Pipeline is an Ohio limited liability company that is registered to do business in Ohio and as of this date is a direct and wholly-owned subsidiary of North Coast. Generation Pipeline intends to take ownership of and operate the Oregon Lateral Pipeline for the purpose of transporting and supplying natural gas to the Oregon Clean Energy Center ("OCEC"), an approximately 800 megawatt combined cycle natural gas power plant already under construction

in Oregon, Ohio. On June 15, 2015, Generation Pipeline filed an application with the Public Utilities Commission of Ohio (the "Commission") pursuant to Ohio Revised Code Sections 4905.02, 4905.03(E), and 4905.63, for authority to operate as a natural gas company (Case No. 15-1104-GA-ACE). On September 23, 2015, the Commission entered an order granting Generation Pipeline status as a natural gas company.

Once construction of the Oregon Lateral Pipeline is complete, Generation Pipeline will be responsible for transporting and supplying natural gas to the OCEC by virtue of an assignment of the current transportation service agreement executed between North Coast and Oregon Clean Energy LLC (the owner and operator of the OCEC). For this reason, the Joint Applicants seek approval to assign the Certificate to Generation Pipeline.

As noted above, in keeping with the policy of the State of Ohio, the certificated pipeline will remain subject to the jurisdiction of the OPSB and remain subject to all of the terms and conditions that are applicable to the project as a result of the Staff Report and additional correspondence on the docket related to project conditions. Furthermore, as required pursuant to Section 4906.04 of the Revised Code, Generation Pipeline agrees to abide by all of the terms and conditions that are applicable to the project.

In support of this Joint Application, the Joint Applicants are submitting correspondence attached as Exhibit A confirming Generation Pipeline's commitment to abide by the term and conditions that are applicable to the project. Additionally, a Certificate of Good Standing from the Ohio Secretary of State's office for Generation Pipeline LLC is attached as Exhibit B.

Wherefore, the Joint Applicants respectfully request that, pursuant to Section 4906.04 of the Revised Code, the OPSB approve the assignment of the Certificate for the Oregon Lateral Pipeline to Generation Pipeline LLC. The Joint Applicants request approval of the assignment as soon as possible to support the pending project debt financing.
