Dear Secretary,

Constellation Energy Gas Choice, Inc. ("Licensee") submits this letter as notice to the Public Utilities Commission of Ohio ("Commission") that Licensee changed its name to Constellation Energy Gas Choice, LLC effective December 31, 2015 at 11:59 pm.

Licensee respectfully requests the Commission approve its legal name change to Constellation Energy Gas Choice, LLC, as Licensee's conversion from a corporation to an LLC and associated name is part of an ongoing corporate restructuring.

Given the fact that there will be no changes to any existing customer contracts and only minimal changes to marketing materials where the whole legal entity's name appears, rather than the shortened use of "Constellation", Licensee does not intend to send notifications to customers informing them of the name change. Further, the name change will not otherwise impact the legal ownership, or management of Licensee in any way. Licensee's DUNS number and Federal Tax Identification Number also remain unchanged.

Attached is the notice of amendment changing the name of Licensee to "Constellation Energy Gas Choice, LLC" as filed with the Secretary of State of the State of Delaware (the Licensee's state of incorporation). **A Certificate of Amendment for the State of Ohio dated February 18th 2016 is attached ~~not yet available, but will be forwarded when received.~~** Licensee is also providing an updated corporate structure chart reflecting the name change as of January 1st 2016.

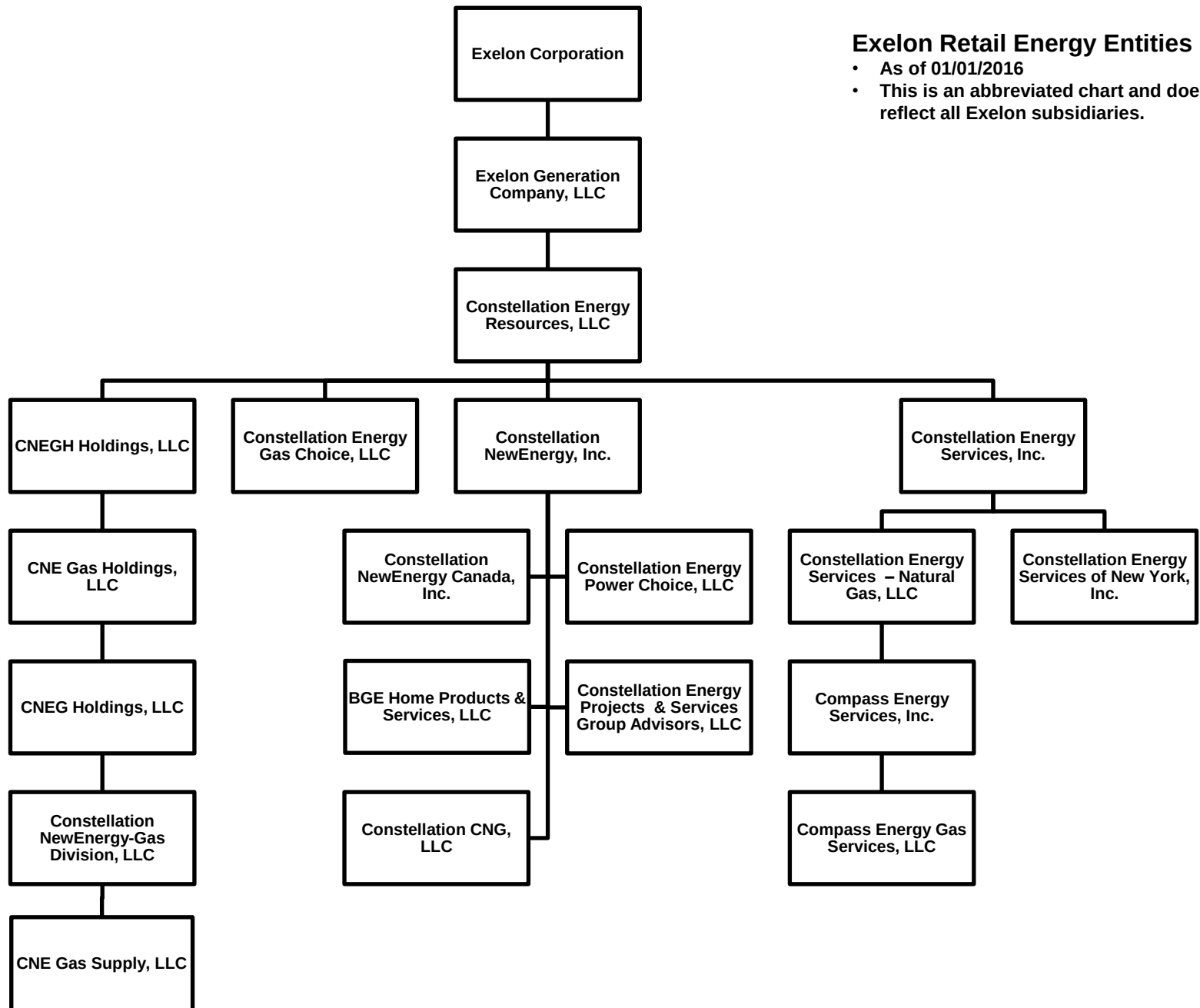
